Description/Analysis

Issue: Currently, parking along the section of 3rd Street between W and X Streets (See Exhibit A) is unregulated, and vehicles park there for extended periods of time. The Sacramento Police Department has received multiple complaints of homeless subjects living in their vehicles and creating an unsafe environment.

Policy Considerations: This recommendation is consistent with the City's strategic plan and the goal of the City Council to achieve sustainability and enhance livability.

Environmental Considerations:

California Environmental Quality Act (CEQA): The current proposal involves restrictions to parking. The proposal is not a "project" in accordance with Section 15378 of the CEQA Guidelines. The proposal does not have a potential for resulting in either direct or indirect physical changes in the environment. Therefore, as determined by the City's Environmental Services Planning Manager, no environmental review is necessary.

Sustainability Considerations: This action supports the City of Sacramento's sustainability goals to improve and optimize the transportation infrastructure.

Other: None.

Commission/Committee Action: None.

Rationale for Recommendation: Parking on both sides of 3rd Street, between W and X Streets (See Exhibit A), is currently unregulated and often occupied by vehicles for extended periods of time. Regulating parking on this section of 3rd Street with "Two Hour Parking, 8:00 a.m. to 6:00 p.m., Excluding Sundays" will open up parking in the area and decrease the number of homeless subjects parking their vehicles for long periods of time.

In response to the Sacramento Police Department's request, a parking occupancy study was conducted between October 16 and October 18, 2012, during 8:00 a.m. to 4:00 p.m. It was determined that the average parking occupancy was 78%.

A vote was not conducted for this request as there are no properties that will be impacted.

Financial Considerations: The cost to implement the recommended parking regulation is estimated to be \$1,131. Sufficient General Funds (Fund 1001) are available in the Parking Services Division operating budget.

Emerging Small Business Development (ESBD): Any goods or services will be purchased in accordance with established City policy.

There are 59 parking spaces along the proposed section of 3rd Street.

BACKGROUND



- B. Regulating parking on this section of 3rd Street with “Two Hour Parking, 8:00 a.m. to 6:00 p.m., Excluding Sundays” will open up parking in the area and decrease the number of homeless subjects leaving their vehicles for extended periods of time.
- C. In response to the Sacramento Police Department’s request, a parking occupancy study was conducted between October 16 and October 18, 2012, during 8:00 a.m. to 4:00 p.m. It was determined that the average parking occupancy was 78%.
- D. A vote was not conducted for this request as there are no properties that will be impacted.
- E. There is sufficient funding within the Parking Services Division’s FY2012/13 operating budget to implement the recommended parking regulation.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The following street will be regulated with “Two Hour Parking, 8:00 a.m to 6:00 p.m., Excluding Sundays”:
 - 3rd Street, both sides, between W and X Streets.
