### **Description/Analysis**

**Issue:** On December 18, 2007, the City Council received a report advising of the City Clerk's intent to hold an election to fill one seat on the Retirement Hearing Commission. A nomination period was opened so that active Sacramento City Employees Retirement System (SCERS) members could be nominated. At the close of the nomination period on January 11, 2008, only one candidate was nominated for the one available seat.

As outlined in Resolution 89-712, when only one candidate is nominated for a seat, the candidate shall automatically be deemed elected by the City Clerk. The Clerk's Notice of Appointment is attached.

In addition, within ten days of the Council receiving this report (February 1, 2008), active SCERS members may file an appeal with the City Clerk challenging the election procedures, results, or any other aspect of the election. If an appeal is filed, the matter will be brought before the City Council for review.



**Background:**

The Retirement Hearing Commission hears issues and appeals relating to the Sacramento City Employees Retirement System (SCERS). The Commission seats five members, two of whom are required to be elected by active members of SCERS. A nomination period was opened so that active SCERS members could be nominated. At the close of the nomination period on January 11, 2008, only one candidate was nominated for the one available seat.


