

# RESOLUTION NO. 2008-119

Adopted by the Sacramento City Council

March 4, 2008

**AMENDING RESOLUTION 2007-792 TO: 1) CORRECTLY IDENTIFY THE CIP NUMBER FOR THE ECONOMIC DEVELOPMENT (ED) PROGRAM FY08 (ZO06) AND 2) REDUCE THE FUNDING TRANSFER FROM ZO06 BY \$111,445.**

## BACKGROUND

A. On November 6, 2007 Resolution 2007-792 was adopted:

1. Approving Plans and specifications for Phase II of the Fulton Avenue Development Project (CB39),
2. Awarding the construction contract for the Phase II base bid to Marques Pipeline Construction in the amount of \$2,255,979,
3. Authorizing and directing the City Manager to execute a contract in the amount not to exceed \$2,255,979 to Marques Pipeline Construction for Phase II of the Fulton Avenue Development Project (PN: CB39), and
4. Authorizing the City Manager to defund and transfer the following funds to the Fulton Avenue Development project (CB39):

- B. As part of the integrity confirmation while moving funds it was identified that CIP fund numbers had been transposed for the FY2007/08 ED-Utilities Program and the ED-Raley at Ascot.
- C. Further refinement of the project scope has also resulted in a savings of \$111,445, therefore, staff is recommending that the original funding transfer from the FY2007/08 ED-Utilities Program and the overall project budget be reduced.


