Recommendation: Adopt a **Resolution:** 1) approving Plans and Specifications for the Florin Road Median Landscaping Project (Phase 2) – Freeport Boulevard to 21st Street (PN: RJ27, T15015401); and 2) awarding the contract for the Florin Road Median Landscaping Project (Phase 2) to Central Pacific Construction in an amount not to exceed \$291,967.

Description/Analysis:

Issue: This project will install landscaping in the Florin Road median between Freeport Boulevard and 21st Street. The purpose of the project is to replace existing asphalt median with landscaping and improve the overall aesthetics in the area.

Bids were received and Central Pacific Construction is the lowest responsive and responsible bidder. City Council approval is necessary to move forward with awarding a construction contract.

Policy Considerations: This action requested herein is consistent with the Sacramento City Code, Title 3 and with the City of Sacramento Strategic Plan goals of achieving sustainability and neighborhood livability.


Environmental Considerations: The Development Services Department, Environmental Planning Services Division has reviewed this project and

determined that is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 1, Section 15301(d) and Class 2, Section 15302(c). Projects exempted under Class 1, Section 15301(d) consists of restoration or rehabilitation of deteriorated or damaged structures, facilities, or mechanical equipment to meet current standards of public health and safety. Projects exempted under Class 2, Section 15302(c) consists of replacement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity.

Rationale for Recommendation: Central Pacific Construction is the lowest responsive and responsible bidder.

Financial Considerations: As of January 30, 2008, the Florin Road Median Landscaping Project (Phase 2) – Freeport Boulevard to 21st Street Project (PN: RJ27, T15015401) has an unobligated balance of \$653,914, which is sufficient to execute the contract with Central Pacific Construction in the amount of \$291,967 and perform construction management of the project.

Emerging Small Business Development (ESBD): Central Pacific Construction meets the City's 20% ESBE goal. To encourage small and emerging business participation, plans and specifications were sent to fifteen (15) plan rooms and construction service organizations for publication. All are directly involved with ESBE construction firms. Staff actively recruited available ESBE firms to participate in the bid process. Project notices were sent to four organizations involved in ESBE recruitment. The project was also announced on the City's Internet site at www.cityofsacramento.org.

Background Information:

This project will install landscaping in the Florin Road median between Freeport Boulevard and 21st Street.

The purpose of the project is to replace existing asphalt median with landscaping and improve the overall aesthetics in the area.

RESOLVES AS FOLLOWS:**


