

RESOLUTION NO. 2008-382

Adopted by the Sacramento City Council

June 10, 2008

ADOPTING THE WILLOWCREEK MAINTENANCE ASSESSMENT DISTRICT ANNUAL BUDGET AND LEVYING ASSESSMENT FOR (FY2008/09)

BACKGROUND:

- A. The Willowcreek Maintenance Assessment District ("District"), as depicted in Exhibit A, was established by the City Council and approved by the property owners on August 18, 1998.
- B. The City Council established the District under Chapter 3.124 of the Sacramento City Code ("Chapter 3.124"), and has previously levied assessments on property in the District to pay for maintenance related to the water quality mitigation program and related services to be provided within the District, all in accordance with Chapter 3.124.
- C. This year's assessments are higher than the previous year's assessments, but this year's assessments are still below the highest authorized amount for this district shown on Exhibit B.
- D. The Council is fully advised in this matter.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Council finds and determines that the background statements A through D are true and correct.
- Section 2. The Supervising Engineer of the Department of Transportation, the person designated by this Council as the Engineer of Work for the District, is hereby directed to file an annual report in accordance with the provisions of Section 3.124.190 of the Sacramento City Code.
- Section 3. The City Council:
 - (a) adopts the annual budget set forth in the FY2008/09 Engineer's Annual Report; and
 - (b) levies the assessment set forth in the FY2008/09 Engineer's Annual Report.
- Section 4. Exhibits A and B are part of this resolution.






