Description/Analysis

Issue: On July 21, 2005 the City Council passed Resolution 2005-553 approving an inter-agency agreement with Sacramento County Sheriff's Department for peace officer assignment to the Department of Parks and Recreation's Alternative Sentencing Program. The agreement (City Agreement Number 2005-0100) was a three-year agreement, with a one-year term and renewal options for a second and third year. The City and County executed a renewal FY2006/07; however, the County indicated it wanted to renew the agreement under different terms for the final year FY2007/08, resulting in the need to execute a new agreement. Due to City staff oversight and delays in the negotiation process, City Agreement 2005-0100 was not renewed for FY2007/08, nor was a new agreement executed. As a result, the County has continued to provide, and the City has continued to accept, the services of deputy sheriffs for the Alternative Sentencing Program without an agreement since July 1, 2007.

Due to the long-standing good relationship between the City and County and the fact that the County has provided, and the City has accepted, a valuable service, staff requests City Council approve an agreement retroactive to July 1, 2007, for an amount not to exceed \$128,062 for the assignment of deputy sheriffs to the Department of Parks and Recreation's Alternative Sentencing Program in FY2007/08.

Policy Considerations: The partnership with the County of Sacramento Sheriff's Department to provide oversight and supervision of the Alternative Sentencing Program is consistent with the City's strategic plan to enhance sustainability and liveability and to expand economic development throughout the City of Sacramento.

Using creative strategies to finance park maintenance service delivery is consistent with the policies the City Council adopted *2005-2010 Parks and Recreation Master Plan* including:

Policy 6.1: Develop and implement financing strategies that provide for the meeting of Department Service Level Goals for all capital, maintenance, programming, staffing and operational needs from dedicated sources to the maximum extent possible, including new and innovative approaches, as approved by elected officials and/or the electorate as needed.

Environmental Considerations: None with this report.


Commission/Committee Action: None required with this report.

Rationale for Recommendation: The Alternative Sentencing Program has proven to be an effective resource in community clean-ups and the mitigation of neighborhood blight in commercial corridors citywide. Approval of the retroactive agreement will continue the good relationship with the County for provision of the program's valuable services.

Financial Considerations: The Park Operations Division has funding designated for the Alternative Sentencing Program and will finance program costs from its General Fund budget.

Emerging Small Business Development (ESBD): Not applicable. The Sacramento County Sheriff's Department is the only vendor for these services.

BACKGROUND INFORMATION

Program Information

For approximately 20 years, the City's Park Operations Division and the Sacramento County Sheriff's Department have worked jointly on community clean-ups of vacant lots, commercial corridors, alleys, creeks and open space utilizing labor from individuals who were convicted of misdemeanor crimes and sentenced to Sacramento County jail. Upon recommendation from the Court, the Sheriff's Department exercises its discretion to accept the Court's recommendation of these individuals into the work project, or "Alternative Sentencing Program."

The Alternative Sentencing inmate work crew consists of nonviolent misdemeanor offenders, a Sacramento County Sheriff's Deputy, a City of Sacramento Park Maintenance Worker II and a Park Maintenance Worker. The work crew is assigned to various locations throughout the City 260 days a year Tuesday through Saturday, 7:00 a.m. until 3:30 p.m.

The Alternative Sentencing inmate work crew has proven to be an effective resource in the mitigation of neighborhood blight in commercial corridors and public areas. The Mayor/Council Office, City staff and Sacramento Housing and Redevelopment Agency frequently request the services of the work crew for projects throughout the City.

APPROVING A ONE-YEAR AGREEMENT WITH THE COUNTY OF SACRAMENTO FOR THE ASSIGNMENT OF DEPUTY SHERIFFS TO THE DEPARTMENT OF PARKS AND RECREATION'S ALTERNATIVE SENTENCING PROGRAM

BACKGROUND

- A. For approximately 20 years, the City's Park Operations Division and the Sacramento County Sheriff's Department have worked jointly on community clean-up of vacant lots, commercial corridors, alleys, creeks and open space utilizing labor from individuals who were convicted of misdemeanor crimes and sentenced to County jail.
- B. City Agreement Number 2005-0100 was a three-year agreement between the City and the County of Sacramento for the assignment of deputy sheriffs to the Department of Parks and Recreation's Alternative Sentencing Program, with a one-year term and renewal options for a second and third year. The City and County executed a renewal FY2006/07; however, the County indicated it wanted to renew the agreement under different terms for the final year FY2007/08, resulting in the need to execute a new agreement. Due to City staff oversight and delays in the negotiation process, City Agreement 2005-0100 was not renewed for FY2007/08, nor was a new agreement executed.
- C. The County of Sacramento Sheriff's Department has assigned deputy sheriffs to the Department of Parks and Recreation Alternative Sentencing Program in good faith without an agreement during FY2007/08 while the parties have negotiated the terms of a new agreement. To continue the good relationship with the County, and to continue to provide the County's valuable services to the City of Sacramento, the County is owed compensation for peace officer services rendered to the City's Alternative Sentencing Program in FY2007/08, the cost of which will not exceed \$128,062.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Manager or City Manager's designee is authorized to execute an agreement with the County of Sacramento retroactive to July 1, 2007, for an amount not to exceed \$128,062 for the assignment of deputy sheriffs to the Department of Parks and Recreation's Alternative Sentencing Program during FY2007/08.
