**Title:** Calling and Giving Notice of a Measure for Inclusion on the November 4,  
2008 General Municipal Election Ballot

**Location/Council District:** Citywide

**Recommendation:** Adopt a **Resolution** calling and giving notice of a measure to be placed on the November 4, 2008, ballot regarding the Gang Prevention and Youth Investment Act of the City of Sacramento and levying a transaction and use tax to be administered by the State Board of Equalization that will provide approximately \$16 million annually in new funding to the City for gang and youth violence prevention programs.

### Description/Analysis

**Issue:** Council action is necessary to place a measure before the voters of the jurisdiction.

**Policy Considerations:** This action is consistent with California Elections Code.

**Environmental Considerations:** None

**Commission/Committee Action:** None.

**Rationale for Recommendation:** On July 29, 2008, the City Council will consider approving a measure adding Chapter 3.26 to the City Code of the City of Sacramento to add the Gang Prevention and Youth Investment Act of the City of Sacramento and to levy a transaction and use tax to be administered by the State Board of Equalization subject to the voters' approval in accordance with Proposition 218. If the City Council sends the measure to the ballot, then as required by California Elections Code, the City Council must adopt a resolution that will place the measure on the November 4, 2008 General Municipal Election ballot.

**Financial Considerations:** The estimated cost to add an additional citywide contest to the November ballot is approximately \$22,336 per contest.

**CALLING AND GIVING NOTICE OF THE SUBMITTAL TO THE VOTERS OF A QUESTION PROPOSING THE ADDITION OF CHAPTER 3.26 TO THE CITY CODE RELATED TO A GANG PREVENTION AND YOUTH INVESTMENT MEASURE TO BE INCLUDED IN THE CONSOLIDATED GENERAL MUNICIPAL ELECTION OF NOVEMBER 4, 2008**

**BACKGROUND**

- A. On December 11, 2007, the City Council adopted a resolution calling for, and giving notice of, a General Municipal Election to be held on November 4, 2008. The same day, the City Council also adopted a resolution requesting consolidation of the General Municipal Election with the Statewide General Municipal Election of November 4, 2008.
- B. On July 29, 2008, the City Council approved a measure proposing the addition of Chapter 3.26 to the City Code related to gang prevention and youth investment subject to the voters' approval in accordance with Proposition 218.
- C. The City Council desires to submit that measure to the voters at the November 4, 2008, General Municipal Election.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

SECTION 1: The City Council hereby orders that the following question be submitted to the voters in the City of Sacramento, California on Tuesday, November 4, 2008:

**Measure – Sacramento Gang Prevention and Youth Investment Measure**

"Sacramento Gang Prevention and Youth Investment Measure. To reduce gang and youth related crimes and increase public safety by funding prevention strategies including after-school, job training, teen center programs, and expand community policing and violence reduction efforts, shall the City of Sacramento sales tax be increased by one-quarter cent for a period of 15 years with mandatory evaluation reports, annual independent audits, and a citizen oversight committee to ensure funds are properly expended?" SECTION 2: The text of the proposed measure to be submitted to the voters is attached as Exhibit A.

SECTION 3: The ballots to be used at the election shall be in the form and content as required by law.

SECTION 4: The polls for the election shall open at 7:00 a.m. on the day of the election and shall remain open continuously from that time until 8:00 p.m. of the same day when the polls shall be closed, except as provided in section 14401 of the Elections Code.

SECTION 5: In all particulars not recited in this resolution, the election shall be held and conducted as provided by the law for holding municipal elections.

SECTION 6: Notice of the time and place of holding the election is hereby given and the City Clerk is hereby authorized, instructed and directed to give further or additional notice of the election, in the time, form, and manner required by law.

SECTION 7: The City Clerk shall certify the passage and adoption of this resolution and enter it into the book of original resolutions.
