**Background:**

On July 29, 2008, the City Council will consider adopting a resolution ordering that the proposed addition Chapter 3.26 to the City Code of the City of Sacramento to add the Gang Prevention and Youth Investment Act of the City of Sacramento and to levy a transaction and use tax to be administered by the State Board of Equalization be submitted to the voters at the consolidated election on Tuesday, November 4, 2008. If the City Council authorizes placement the measure on the ballot, then Council may consider adopting a resolution authorizing one or more members of the City Council to submit the City's argument in favor of the measure.

As provided in California Elections Code section 9287, if more than one argument for or against a measure is submitted to the City Clerk, then the Clerk shall select only one argument for and one argument against the measure for printing in the official sample ballot. In selecting the argument, the City Clerk shall give preference and priority in the following order: 1) the legislative body, or a member or members of the legislative body authorized by that body; 2) the individual voter, or bona fide association of citizens, or combination of voters and associations, who are the bona fide sponsors or proponents of the measure; 3) a bona fide association of citizens; or 4) individual voters who are eligible to vote on the measure.

Adopting a resolution authorizing one or more members of the City Council to submit the City's argument ensures that the Council's argument will be selected for inclusion in the official sample ballot.

**AUTHORIZING ONE OR MORE MEMBERS OF THE CITY COUNCIL TO SUBMIT THE COUNCIL'S WRITTEN ARGUMENT IN FAVOR OF THE PROPOSED ADDITION OF CHAPTER 3.26 TO THE CITY CODE RELATED TO GANG PREVENTION AND YOUTH INVESTMENT TO BE SUBMITTED TO THE VOTERS AT THE CONSOLIDATED ELECTION ON TUESDAY, NOVEMBER 4, 2008**

**BACKGROUND**

- A. On July 29, 2008, the City Council adopted a resolution ordering that the proposed addition of Chapter 3.26 to the City Code related to gang prevention and youth investment be submitted to the voters at the consolidated election to be held on November 4, 2008.
- B. The City Council desires to submit an argument for inclusion in the official sample ballot.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

Section 1. The City Council hereby authorizes \_\_\_\_\_
