actions in support of the Strategy; and 2) **Redevelopment Agency No. 2009- 025 as amended** a) approving the housing through units leasing program and authorizing the Executive Director to appropriate and expend an additional \$380,000 of the Merged Downtown Tax Increment Housing Set Aside funds to provide transitional housing and permanent supportive housing; b) authorizing the SHRA Executive Director to execute all agreements and contracts, as approved by Agency Counsel, with the appropriate entities and take all necessary actions to carry out the Strategy consistent with California Redevelopment Law.
