

RESOLUTION NO. 2009-311

Adopted by the Sacramento City Council

May 19, 2009

ANNEX PORTIONS OF 6TH, 7TH, AND R STREETS INTO THE SOUTHSIDE PARK RESIDENTIAL PERMIT PARKING AREA (H).

BACKGROUND

- A. In 1982 the City Council adopted a resolution to implement the Southside Park Residential Permit Parking Area (H), which is bounded by 3rd Street, 12th Street, Q/R Alley, and W Street, and to regulate parking with two-hour parking restrictions, except with a permit.
- B. Parking on the proposed portions of 6th, 7th, and R Streets, is currently regulated with 10-hour metered parking and is often occupied by non-residents, such as commuters.
- C. The residents requested that the portions of 6th, 7th, and R Streets be annexed into the Southside Park Residential Permit Parking Area (H) and regulated with "Two Hour Parking, Except with Permit." These new parking requirements will be consistent with existing regulations.
- D. In response to the resident's requests, a parking occupancy study was conducted between February 12th and February 14th, during 8:00 a.m. to 4:00 p.m. It was determined that the number of parking spaces occupied by non-residents (77%) was sufficient enough to adversely impact the residents of those areas.
- E. A letter outlining the proposed regulations and soliciting comments was sent to the residents who would be impacted by the changes. Of the 25 residents who live in the impacted area, 19 (76%) responded: 19 (100%) of the respondents voted in favor of the annexation and zero (0%) voted against.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The following streets are annexed into the Southside Park Residential Permit Parking Area (H) and parking will be regulated with "Two Hour Parking, Except with Permit."
- 6th Street, both sides, from Q/R alley to R Street.
 - 7th Street, both sides, from Q/R alley to R Street.
 - R Street, both sides, from 6th Street to 7th Street.




