

RESOLUTION NO. 2009-372

APPROVING PLANS AND SPECIFICATIONS AND AWARD CONTRACT FOR THE MCKINLEY AREA STREETLIGHT REPLACEMENT PROJECT (T15073201)

BACKGROUND

- A. Streetlights and their associated infrastructure (conduits, conductors, and foundations) in the McKinley Area have reached or exceeded their design life. The City, in conjunction with Councilmember Steve Cohn's office and neighborhood representatives, began efforts to replace the streetlights in 2004. Construction plans were developed by a consultant in 2005. These plans have been updated to meet current standards and specifications. Existing streetlights will be refurbished or replaced with replicas. The City has acquired customized replicas for this project.
- B. The project was advertised and bids were received on April 29, 2009. The results are summarized below:

The engineer's estimate is \$665,000. It is recommended that the contract be awarded to Pacific Excavation.

- Section 2. The construction contract is awarded to Pacific Excavation in the amount of \$308,683.
- Section 3. The City Manager is authorized to execute a contract with Pacific Excavation for a not-to-exceed amount of \$308,683 for the McKinley Area Streetlight Replacement Project (T15073201).


