Description/Analysis

Issue: As provided in California Elections Code and the City Charter, the City Clerk shall submit the "Certificate of Petition" to the City Council at the next regular meeting after receipt of the certifications. The official certificates declare that both initiative petitions to have affixed thereto sufficient valid signatures to qualify for their placement on the ballot (Attachment 2a/b). Options available to the City Council as to the adoption or placement of the issues on the ballot are presented in a separate staff report by the City Attorney's Office.

Environmental Considerations: None


Commission/Committee Action: None

Background:

On December 12, 2008, two Notices of Intent to circulate initiative petitions (ordinance and charter amendment) were filed with the City Clerk's Office by proponent Thomas W. Hiltachk. The initiative ordinance described as the "Independent Budget Analyst Act of 2009" would amend the Sacramento City Code creating a new Office of the Independent Budget Analyst. The department's function would be to assist the City Council in conducting budgetary inquires and making budgetary decisions. The initiative charter amendment described as the "Government Accountability and Charter Reform Measure of 2009" would modify the Sacramento City Charter to replace the current "Council-Manager" form of government with a "Mayor-Council" form.

The signed petitions were due in the City Clerk's Office no later than June 27, 2009. On June 26, 2009, the proponent submitted both petitions to the City Clerk. Upon review by the Clerk, the number of signatures affixed to the face of the petitions appeared sufficient to accept the petitions for filing. The petitions were submitted to the Sacramento County Registrar of Voter's Office to determine the actual number of valid signatures affixed. The Registrar of Voters completed the signature verification process, and the attached certificates confirm the sufficiency of both petitions.


