Description/Analysis

Issue: To provide the members of the City Council who do not serve on the Personnel and Public Employees Committee with an opportunity to comment on applicants to certain city boards and commissions whose memberships are geographically based. The opportunity for comment in an open forum provides increased awareness of city business and allows full participation in compliance with the Brown Act.

Policy Considerations: The membership qualifications on the Parks and Recreation Commission are aligned with the community plan areas.
