### **CERTIFICATION OF ALKALI FLAT REDEVELOPMENT ADVISORY COMMITTEE (RAC) ELECTION**

#### **BACKGROUND**

- A. In 2001, The City Council adopted procedures for governing Redevelopment Advisory Committees known as the PAC/RAC Policy.
- B. In order to conform to the PAC/RAC Policy, the Alkali Flat Redevelopment Advisory Committee Operating Guidelines ("Guidelines") were adopted on May 17, 2005 establishing the Alkali Flat Redevelopment Advisory Committee (RAC).
- C. The Alkali Flat Redevelopment Advisory Committee election was held on August 25, 2009, in accordance with the election procedures mandated on the RAC Operating Guidelines.
- D. On Wednesday, August 26, 2009, the ballots for candidates running for seats on the Alkali Flat RAC were canvassed by the Office of the City Clerk.




