Title: Agreement: Amendment to Subgrant for the Workforce Investment Act, Title I, Youth Employment Program and the American Recovery and Reinvestment Act

Recommendation: Adopt a resolution 1) authorizing the City Manager, or designee, to execute Supplement No. 1 to City Agreement 2009-0815 to the Workforce Investment Act (WIA), Title I, Youth Program and the American Recovery and Reinvestment Act (ARRA) subgrant agreement with the Sacramento Employment and Training Agency (SETA) and sign any other documents required or deemed necessary to implement the subgrant in Fiscal Years 2009/10 and 2010/11 in an amount not to exceed \$142,324; 2) amend the Fiscal Year (FY) 2009/10 and 2010/11 budgets as necessary to reflect the operation of the program; and, 3) approving the resolution required by SETA.

Description/Analysis

Issue: On February 17, 2009, the Federal Economic Stimulus Package known as the ARRA was signed into law. Immediately following, the Sacramento Employment and Training Agency (SETA) awarded the Department of Parks and Recreation a subgrant under the Workforce Investment Act, Title I, Youth Program and the American Recovery and Reinvestment Act to extend the City's Youth Employment program to an additional 60 youth in the summer of 2009. In March of 2010, SETA notified the City of its intent to extend the subgrant award for one additional hiring season which is May 1 through September 30, 2010. Staff is requesting approval to continue this program for its second and final year.

Policy Considerations: Staff's recommendation is consistent with the policies in the City Council Adopted *2005-2010 Parks and Recreation Master Plan* and is consistent with the City's strategic plan to achieve sustainability and enhance livability in the City.

Environmental Considerations:

California Environmental Quality Act (CEQA):

This report concerns administrative activities that will not have any significant effect on the environment and that do not constitute a "project", as defined by the following sections of the CEQA Guidelines (Title 14 Cal. Code Reg. § 15000 et seq.): Sections 15061 (b)(3); 15378(b)(2).

Sustainability Considerations: The agreement between SETA and the City of Sacramento have been reviewed for consistency with the goals, policies and target of the Sustainability Master Plan and the 2030 General Plan.


Commission/Committee Action: None with his item

Rationale for Recommendation: Continued participation in this program is consistent with the City's Strategic plan and supports the Parks and Recreation Department's *Master Plan 2005-2010* by committing to support youth development which includes providing youth with employment opportunities.

Financial Considerations: This program is funded by Federal ARRA funds in an amount not to exceed \$142,324. The City will be reimbursed by SETA, the local grantor, for expenses incurred by the City for the Youth Employment program. The general fund match requirement is met through existing resources allocated for general youth programming.

Emerging Small Business Development (ESBD): Purchase of supplies and equipment will be made in accordance with the City's Emerging and Small Business Development program requirements.

Background

On February 17, 2009, the Federal Economic Stimulus Package known as the American Recovery and Reinvestment Act of 2009 (ARRA) was signed into law. As a result, the Department of Parks and Recreation applied for and received a subgrant under the Workforce Investment Act, Title I, Youth Program and the American Recovery and Reinvestment Act from the Sacramento Employment and Training Agency (SETA) to operate a youth employment program for 60 youth in the summer of 2009.

This subgrant provided additional funding for an already funded youth employment program funded by SETA. Due to the availability of additional funding for the year 2010, SETA is awarding the City of Sacramento subgrant funding for a second and final season of additional youth employment program funding to serve another 60 Sacramento youth.

Funding will support program management costs and support services in an amount not to exceed \$142,324. The term of the subgrant is from May 1, 2010 to September 30, 2010.

AMEND WIA ARRA SUBGRANT FUNDED YOUTH EMPLOYMENT PROGRAM

BACKGROUND

- A. Following passage of the Federal Economic Stimulus Package known as the American Recovery and Reinvestment Act of 2009 on February 17, 2009, the City of Sacramento applied for, and was awarded, a Sacramento Employment and Training Agency (SETA) subgrant under the Workforce Investment Act, Title I, Youth Program and the American Recovery and Reinvestment Act to extend the City's Youth Employment program to an additional 60 youth in the summer of 2009.
- B. The subgrant award provided additional funding for an already funded youth employment program funded by SETA. Due to the availability of additional funding for 2010, SETA is awarding the City of Sacramento another subgrant under the Workforce Investment Act, Title I, Youth Program and the American Recovery and Reinvestment Act for a second and final season of additional youth employment program funding to serve another 60 Sacramento youth in a subcontracting capacity.
- C. Funding will support program management costs and support services in an amount not to exceed \$142,324. The term of the subgrant is from May 1, 2010 to September 30, 2010.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Manager, or designee, is authorized to execute Supplement No. 1 to City Agreement 2009-0815 to the Workforce Investment Act (WIA), Title I, Youth Program and the American Recovery and Reinvestment Act (ARRA) subgrant agreement with the Sacramento Employment and Training Agency (SETA) and sign any other documents required or deemed necessary to implement the subgrant in Fiscal Years 2009/10 and 2010/11 in an amount not to exceed \$142,324.
- Section 2. The Fiscal Year 2009/10 and 2010/11 budgets are amended to reflect the operation of the program.
- Section 3. The resolution required by SETA (attached as Exhibit A and made a part of this Resolution) is approved.
