Recommendation: Adopt a **Resolution:** 1) awarding the contract to provide exhibition cases for the Crocker Art Museum to Gizmo Art Production, Inc., the lowest responsive and responsible bidder, in an amount not to exceed amount of \$484,706.24, and authorizing the Interim City Manager or his designee to execute the contract; 2) rejecting the lowest bidder, Mill Creek Associates, as non-responsive.

Description/Analysis

Issue: As part of its expansion project, the Crocker Art Museum is purchasing exhibition cases to support the expansion. Exhibition cases include items such as freestanding display cases, shelving, and built in wall display cases. Because of the high quality construction and materials needed to display the Crocker's valuable artwork, these cases are custom made. Staff recommends rejecting the apparent low bidder, Mill Creek Associates, as non-responsive because they did not bid on all the items in the bid package as required in the specifications; accepting the second low bidder, Gizmo Art Production, Inc., as the lowest responsive and responsible bidder; and, awarding a contract for the manufacture and installation of exhibition cases to Gizmo Art Production, Inc., in the not to exceed amount of \$484,706.24.

Policy Considerations: This report is consistent with the City's Strategic Plan Goal to preserve and expand the arts and culture.

Environmental Considerations:

California Environmental Quality Act (CEQA): This report concerns administrative activities that do not constitute a Project under the California Environmental Act (CEQA), title 14, section 15378(b)(2) of the California Code of Regulations.

Sustainability Considerations: The exhibition cases contract has been reviewed for consistency with the goals, policies, and targets of the City's Sustainability Master Plan (SMP).

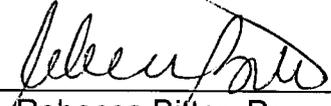
Rationale for Recommendation: The City received bids for exhibition cases on April 14, 2010. Thirteen bids were received and Gizmo Art Production, Inc., was determined to be the lowest responsive and responsible bidder. The apparent lowest bidder, Mill Creek Associates, was determined non-responsive because they did not bid on all items in the bid package as required in the specifications. 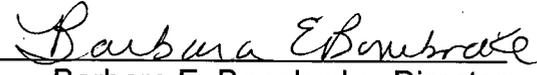

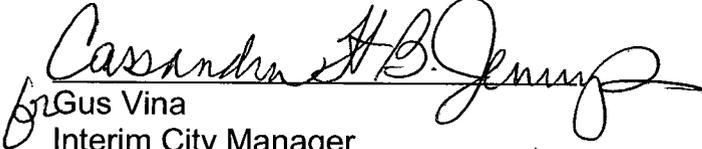

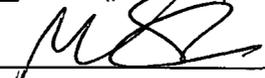
