Title: Externally Funded Program: Anti-Vehicle Theft Enforcement Program

Location/Council District: Citywide

Recommendation: Adopt a **Resolution** authorizing the City Manager, or designee, to: 1) accept the distribution of funds for the Anti-Vehicle Theft Enforcement Program, on behalf of the City of Sacramento, administered by Sacramento County under the authority of Vehicle Code Section 9250.14, 2) establish a new Externally Funded Program (EFP) (E11005400) for the Anti-Vehicle Theft Program, and 3) adjust revenue and expense budgets based on annual receipts from the California Department of Motor Vehicles (DMV).

Description/Analysis

Issue: The Sacramento Police Department (SPD) is requesting renewed authorization to accept and expend funds collected from state transportation fees, administered by Sacramento County, through the collection of vehicle registration fees mandated by Section 9250.14(a)(1) of the California Vehicle Code to be used for the Anti-Vehicle Theft Enforcement Program. The program has funded two detective positions, supplies, vehicles, and equipment in the SPD since 1992 (Resolution 93-031, 2005-792). In addition, the SPD is requesting authority to establish a new Externally Funded Program (E11005400) for the project and adjust revenue and expense budgets based on the annual receipts from the DMV.

Policy Considerations: Section 11 of City Council Resolution 2009-406 requires City Council approval to establish an Externally Funded Program in excess of \$100,000 and adjust revenue and expense budgets in excess of \$100,000. The recommendations are consistent with the past practice of using this funding to improve law enforcement and community relationships.

Environmental Considerations: This activity is not subject to the California Environmental Quality Act (CEQA) because it does not constitute a “project” as defined in section 15378 of the CEQA Guidelines, and is otherwise exempt pursuant to Sections 15321(b) (law enforcement activities) and 15061(b)(3) (no significant effect on the environment) of the CEQA Guidelines.

Commission/Committee Action: None

Rationale for Recommendation: The recommendations are required per Resolution 2009-406 and are consistent with the past practice of using this funding to improve law enforcement and community relationships. The distributions of funds through this program are specifically designated to combat vehicle theft and crimes.

Financial Considerations: Program funds are distributed quarterly. Vehicle Code Section 9250.14(a)(1) authorizes the ongoing distribution of funds through January 1, 2018. The recommended adjustments will have no current or future impact on the General Fund.

EXTERNALLY FUNDED PROGRAM: ANTI-VEHICLE THEFT ENFORCEMENT PROGRAM

BACKGROUND:

- A. The Anti-vehicle Theft Enforcement Program is a statewide program to combat vehicle theft. The State of California provides funds from the collection of vehicle registration fees as authorized in California Vehicle Code Section 9250.14(a)(1) to each county. The county then distributes the funds to participating cities. Funds are distributed quarterly and are specifically designated to combat vehicle theft crimes.
- B. Vehicle Code Section 9250.14 authorizes the ongoing distribution of funds through January 1, 2018.
- C. The Police Department's recipient of these funds aligns with the past practice of using this funding to improve law enforcement and community relationships, and will ensure the continuation of the Anti-Vehicle Theft Enforcement Program.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Manager, or his designated representative, is hereby authorized to accept the distribution of funds for the Anti-Vehicle Theft Enforcement Program, on behalf of the City of Sacramento, administered by the Sacramento County under the authority of Vehicle Code Section 9250.14(a)(1).
- Section 2. The City Manager, or designated representative, is authorized to establish a new Externally Funded Program (EFP) (E11005400) for the Anti-Vehicle Theft Program.
- Section 3. The City Manager, or designated representative, is authorized to adjust the appropriate revenue and expense budgets based on annual receipts from the California Department of Motor Vehicles.
