Description/Analysis

Issue: This report requests authorization to enter into an agreement with the California Department of Corporations ("Corporations") for the City to provide solid waste collection services during FY2010/11. City will be reimbursed up to \$2,635 for the services provided.

Policy Considerations: Pursuant to Section 3.04.010 of the City Code, Council approval is required for contracts unrelated to real property that bring revenue or income to the City in any amount.

Environmental Considerations:

California Environmental Quality Act (CEQA): This report concerns administrative activities that will not have a significant effect on the environment, and does not constitute a "project" as defined by the California Environmental Quality Act (CEQA) [CEQA Guidelines Sections 15061(b)(3); 15378(b)(2)].

Sustainability Considerations: Solid Waste collection service to Corporations will help the keep the City clean of municipal solid waste (MSW) and meet mandated MSW diversion requirements.

Commission/Committee Action: Not applicable.

Rationale for Recommendation: The City's Solid Waste division of the Department of Utilities provides commercial refuse and recycling collection services throughout the City. Since 2005, Corporations has contracted with the City of Sacramento for solid waste collection services and has once again requested service by the City for FY2010/11.

Financial Considerations: No funding is requested with this item. Corporations will be billed by the Department of Utilities for solid waste collection services for an amount not to exceed \$2,635 per the Council approved FY2010/11 Solid Waste commercial rate sheet.



**AGREEMENT WITH CALIFORNIA DEPARTMENT OF CORPORATIONS TO ALLOW
THE CITY TO PROVIDE SOLID WASTE COLLECTION SERVICES**

BACKGROUND

- A. The California Department of Corporations has requested City Solid Waste services provide solid waste collection services for FY2010/11.
- B. The California Department of Corporations will reimburse the City for the cost to provide service up to \$2,635.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL
RESOLVES AS FOLLOWS:**

- Section 1. The City Manager or designee is authorized to execute an agreement with the California Department of Corporations for the City to provide solid waste collection services for an annual amount not to exceed \$2,635.
