The order and estimated time for Agenda items are listed for reference and may be taken in any order deemed appropriate by the legislative body.

The Agenda provides a general description and staff recommendations; however, the legislative bodies may take action other than what is recommended. Hard copies are available at the Office of the City Clerk and all written material received is available at the meeting for public review.
