

RESOLUTION NO. 2011-495

APPROVE PLANS AND SPECIFICATIONS, AWARD CONTRACT, AND AUTHORIZE THE CITY MANAGER TO EXECUTE THE CONTRACT FOR THE I STREET TO J STREET FROM 20TH STREET TO 27TH STREET STREETLIGHT INSTALLATION PROJECT (T15115300)

BACKGROUND

- A. Many streets within the project boundary of I Street to J Street from 20th Street to 27th Street currently do not have street lighting, except for a few streetlights at signalized and non-signalized intersection. The proposed improvements will install approximately 86 new ornamental streetlights and new underground infrastructure within the project boundary. These streetlights will enhance pedestrian safety, community livability, and access to transit and commerce on J Street. This project will also provide electrical outlets at the top of each new streetlight on J Street. The energy usage of the outlets shall be paid by the permitted user.
- B. The project was advertised and a total of four bids were received on June 29, 2011. All Phase Excavating as the lowest responsive and responsible bidder.
- C. Contract award for All Phase Excavating is recommended as the lowest responsive and responsible bidder.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. Plans and Specifications for the I Street to J Street from 20th Street to 27th Street Streetlight Installation Project (T15115300) are approved.
- Section 2. The construction contract is awarded to All Phase Excavating in an amount not to exceed \$295,775.
- Section 3. The City Manager is authorized to execute a construction contract with All Phase Excavating in an amount not to exceed \$295,775 for the I Street to J Street from 20th Street to 27th Street Streetlight Installation Project.
- Section 4. Exhibit A is attached and is part of this Resolution.





