## Description/Analysis

### CONFIRM APPOINTMENT OF CITY COUNCILMEMBERS TO SERVE ON COUNCIL STANDING COMMITTEES AND VARIOUS REGIONAL AUTHORITIES, AGENCIES, COMMISSIONS, AND COMMITTEES FOR CALENDAR YEAR 2012

#### BACKGROUND

- A. Chapter 12(B)(a) of the City Council's adopted Rules of Procedure call for the Mayor's appointment, with approval of the Council, of Councilmembers to serve on Council standing committees. These committees are the Law and Legislation Committee, Audit Committee, and Personnel and Public Employees Committee.
- B. Chapter 12(D)(1) of the City Council's adopted Rules of Procedure call for the Mayor's appointment, with approval of the Council, of Councilmembers to serve on various regional authorities, agencies, commissions, and committees.

- Section 2. The City of Sacramento declares that Councilmembers Angelique Ashby, Steve Cohn, Jay Schenirer and Darrell Fong shall serve on the Audit Committee and that Councilmember Steve Cohn shall act as chair.
- Section 3. The City of Sacramento declares that Councilmembers Angelique Ashby, Robert King Fong, Kevin McCarty and Bonnie Pannell shall serve on the Personnel and Public Employees Committee and that Councilmember Angelique Ashby shall act as chair.
- Section 4. The City of Sacramento declares that the Mayor and Councilmembers shall serve on the following regional authorities, agencies, commissions, and committees as indicated on the attached Exhibit A as primary representatives or alternates where applicable.

**RESOLUTION NO.**

**ADOPTED BY THE SACRAMENTO CITY COUNCIL**

**ON THE DATE OF**

**CONFIRM APPOINTMENT OF CITY COUNCILMEMBERS TO SERVE AS THE CITY OF SACRAMENTO REPRESENTATIVES ON THE SACRAMENTO REGIONAL COUNTY SANITATION DISTRICT (SRCSD) AND THE SACRAMENTO AREA SEWER DISTRICT (FORMERLY KNOWN AS CSD-1) BOARDS OF DIRECTORS, AND APPOINTING ALTERNATE REPRESENTATIVES TO SERVE IN THEIR ABSENCE**

**BACKGROUND**

- A. The Sacramento Regional County Sanitation District and the Sacramento Area Sewer District are governed by boards comprised of representatives from the respective governing bodies of the jurisdictions served by those districts.
- B. Pursuant to Health and Safety Code section 4730.11, the City of Sacramento may appoint one councilmember (and one alternate) to the Sacramento Area Sewer District Board.
- C. Pursuant to Health and Safety Code section 4730.12, the City of Sacramento may appoint five councilmembers (and alternates) to the SRCSD Board.
- D. At the January 5, 2012, City Council meeting, the Mayor presented to the Council a roster of appointments to these Boards for 2012.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. The City of Sacramento declares that Councilmembers Steve Cohn, Robert King Fong, Kevin McCarty, Darrell Fong and Bonnie Pannell shall serve as the City's primary representatives, and that Mayor Kevin Johnson and Councilmembers Angelique Ashby, Sandy Sheedy and Jay Schenirer shall serve as alternate representatives, on the SRCSD Board of Directors.
- Section 2. Councilmember Robert King Fong shall serve as the Sacramento Area Sewer District Board primary representative, and that Councilmember Bonnie Pannell shall serve as the alternate representative to the Sacramento Area Sewer District Board.
