Description/Analysis

Issue: Provide the City Council with the names of the City residents who submitted applications for consideration to a seat on the new Planning and Design Commission. The commission has 13 members. Each councilmember, including the mayor, can recommend one applicant for appointment. The interview and nomination of the four members by the Personnel and Public Employees Committee will run concurrently. The appointments are scheduled to be announced by the Mayor at the June 12 City Council meeting, with an anticipated confirmation by the full Council on June 26, 2012.

Each member of the City Council should forward the name of his/her nominee to the Mayor and City Clerk no later than Thursday, June 7, 2012.

Rationale for Recommendation: Provide the City Council with the information needed to consider individuals for nomination to the new Planning and Design Commission.
