

RESOLUTION NO. 2012-289

Adopted by the Sacramento City Council

July 31, 2012

AMENDING THE FISCAL YEAR 2012/13 ADOPTED CITY BUDGET FOR THE NORTH FRANKLIN PROPERTY AND BUSINESS IMPROVEMENT DISTRICT, FUND 2217

BACKGROUND

- A. The North Franklin Property and Business Improvement District No. 2012-03 (District), the boundaries of which are depicted in Exhibit A, was established by the City Council and approved by the property owners on July 31, 2012.
- B. The City Council established the District under the Property and Business Law of 1994 (California Streets and Highway Code – Sections 36600 to 36671) (PBID Law) and has previously levied assessments on property in the District to pay for improvements and services to be provided within the District, all in accordance with the PBID Law.
- C. The City Council is fully advised in this matter.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The background statements in paragraphs A through C above are true.
- Section 2. The District's FY2012/13 assessment and expenditure budget of \$141,274 are hereby amended as set forth in Exhibit B.
- Section 3. The Finance Director is hereby authorized to expend \$3,990 of the budgeted funds for the Department of Finance to provide services for the District, as set forth in Exhibit B, which will be reimbursed by the District.
- Section 4. Exhibits A and B are part of this resolution.






