

RESOLUTION NO. 2012-296

Adopted by the Sacramento City Council

July 31, 2012

AUTHORIZING THE CITY COUNCIL OR MEMBERS OF THE CITY COUNCIL TO SUBMIT WRITTEN ARGUMENT(S) FOR VARIOUS MEASURE(S) TO BE SUBMITTED TO THE VOTERS AT THE GENERAL MUNICIPAL ELECTION ON TUESDAY, NOVEMBER 6, 2012

BACKGROUND

- A. On December 6, 2011, the City Council adopted a resolution calling for, and giving notice of, a General Municipal Election to be held on November 6, 2012. The same day, the City Council adopted a resolution requesting consolidation of the General Municipal Election with the November 6, 2012 Statewide General Municipal Election.
- B. On June 26, 2012, the City Council approved for placement on the November 6, 2012 ballot a measure to repeal the ordinance enacted by the adoption of Measure 'A' on September 27, 1977, relating to the deposit and collection of yard and garden refuse in the City of Sacramento.
- C. On July 24, 2012, the City Council approved for placement on the November 6, 2012 ballot a measure relating to a transactions and use tax.
- D. The Sacramento City Council desires to submit argument(s) for the measures.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Council hereby authorizes Darrell Fong, Kevin McCarty and Steve Cohn, on behalf of the City Council, to file a written argument **in favor** of the question to repeal an initiative ordinance relating to the deposit of yard and garden refuse in the City of Sacramento:
- Section 2. The City Council hereby authorizes Darrell Fong, Kevin McCarty and Steve Cohn, on behalf of the City Council, to file a written argument **in favor**; and Mayor Kevin Johnson, on behalf of the City Council, to file a written argument **against** the question of a transactions and use tax:
- Section 3. The arguments shall be prepared in accordance with the California Elections Code and the Election Official's printing guidelines available from the City Clerk.
- Section 4. The City Council hereby directs the City Clerk to certify the passage and adoption of this resolution and enter it into the book of origin.


