

RESOLUTION NO. 2012-356

Adopted by the Sacramento City Council

October 23, 2012

APPROVING THE 2013 MEETING SCHEDULE FOR CITY COUNCIL

BACKGROUND

- A. The Brown Act (Government Code section 54954) requires that legislative bodies, except for advisory bodies and standing committees, provide the time and place for regular meetings by ordinance, resolution, or bylaws.
- B. Sacramento City Charter section 31 requires the City Council to hold regular meetings at such times and places as may be fixed by resolution, except that the City Council shall meet after 5:00 pm not less than one evening each week.
- C. Sacramento City Charter section 31 also allows for the designation of four weeks a year when regular City Council meetings need not be held.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

Section 1. The City Council meeting schedule as shown in Exhibit A of this resolution is approved.


