Description/Analysis

Background:

The Maddy Act (Government Code section 54970) requires that, on or before December 31st of each year, a list be prepared showing which city-appointed board, commission, and committee positions expire in the next calendar year. This list (attached) must include which terms will expire, the name of the incumbent, the date of term expiration, and the qualifications for the position.

As noted in the Maddy Act, this information is made available in order to tap into the talent that exists among the citizenry who are too frequently not aware of the opportunities for participation on local advisory boards, commissions, and committees.
