Description/Analysis

Issue: The California Vehicle Code (CVC) requires the City to update the Engineering and Traffic Surveys (E&TS) for each existing speed zone prior to its expiration date and to reevaluate speed limits on segments of roadways that have undergone a significant change in roadway characteristics or surrounding land uses.

The previously adopted City Council Resolution No. 2013-0326 for the citywide posted speed limits needs to be repealed and superseded with a new Resolution in order to re-establish speed limits.

Policy Considerations: The action requested herein is consistent with the City's 2030 General Plan, and is in compliance with the CVC.

Economic Impacts: None.

Environmental Considerations:

California Environmental Quality Act (CEQA): The Community Development Department, Environmental Planning Services Manager has reviewed the proposed action and determined that this project is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 1, Section 15301(c) of the CEQA Guidelines. Projects exempted under Class 1, Section 15301(c), consist of the operation, repair, or minor alteration of existing highways, streets, sidewalks, gutters, bicycle and pedestrian trails, and similar facilities involving negligible or no expansion of use.

Sustainability: This project is consistent with the City's Sustainability Master Plan. It is aimed at addressing the goals and targets set forth in Transportation Infrastructure and Air Quality Focus Areas by improving and optimizing transportation infrastructure with streets that also encourage pedestrians and bicycles.

Commission/Committee Action: None

Rationale for Recommendation: This report recommends that the City Council adopt a Resolution: 1) re-establishing speed limits on 27 speed zones on various streets, 2) reducing speed limits for 3 speed zones, and 3) repealing City Council Resolution No. 2013-0326 for the citywide posted speed limits and replacing it with a new Resolution incorporating these 30 speed zones.

These recommendations are to ensure compliance with CVC in regards to prima facie speed limits. Furthermore, as required by CVC, these recommendations are made on the basis of an E&TS that was performed in accordance with the established traffic engineering practices.

Financial Considerations: No additional funding is requested. The costs associated with performing the speed surveys, and manufacturing and installation of speed limit signs is funded

with local transportation funds from the Department of Public Works, Transportation Division's Operating Budget (Fund 2002). There are no general funds allocated for this project.

Local Business Enterprise (LBE): None, since no goods or services are being pursued with this action.

Background

1. Speed limits in California are governed by Sections 32, 627, 22348 through 22413, 40802, and 40803 of the California Vehicle Code (CVC). According to CVC Section 40802 (“Speed Traps”), a section of a highway or street is a “speed trap” if the prima facie speed limit is not justified by an Engineering and Traffic Survey (E&TS) performed within the specified time period, and enforcement of the speed limit involves the use of radar or other electronic device for measuring the speed of moving objects. Under CVC Section 40803 (“Speed Trap Evidence”), the evidence of a speeding violation based on a speed trap is inadmissible in court. This could result in the inability to prosecute violators of the speed limit. In view of this, the prima facie speed limits on various streets of the City must be determined and established on the basis of an E&TS.

Conducting an E&TS for establishing speed limits is governed by the CVC, and the California Manual on Uniform Traffic Control Devices (MUTCD). When a speed limit is posted on the basis of an E&TS, it should be established using the 85th percentile speed of free-flowing traffic. Since an E&TS is usually valid for a period of 7 years, the City must update the E&TS for each existing speed zones prior to their expiration date. Additionally, the City is required to reevaluate the speed limits on segments of the roadways that have undergone a significant change in roadway characteristics or surrounding land uses.

2. In order to ensure compliance with the requirements set forth in the CVC, an E&TS has been performed for 30 speed zones on various streets of the City. These 30 speed zones include:
 - (I) Re-establishing the speed limit for 27 speed zones; and
 - (II) Reducing speed limit for 3 speed zones.
3. The E&TS for justifying the proposed speed limits were performed in accordance with the requirements set forth in the CVC, California MUTCD and established traffic engineering practices. Exhibit A presents the summary of the E&TS for each of the 30 speed zones along with the proposed speed limits. A brief discussion for each of the proposed speed limits is presented in Attachment 1.
4. Based on the background information presented herein, Staff recommends that the City Council adopt a Resolution approving the re-establishment and reduction of speed limits on the above referenced speed zones.

Attachment 3 presents the list from previously adopted Council Resolution No. 2013-0326 for citywide posted speed limits. The mark-ups reflect changes to the speed limits recommended herein for City Council approval.

5. A list of citywide posted speed limits that are recommended to be adopted as part of a new City Council Resolution is presented in Exhibit B. The subject list

incorporates the re-established speed limits for the 27 speed zones, and the reduction of speed limits for 3 speed zones as summarized in Attachment 1.

6. The previously adopted City Council Resolution No. 2013-0326 for the citywide posted speed limits will need to be repealed and superseded with a new Resolution in order to incorporate the re-established speed limits for the above referenced 27 speed zones, and the reduction of speed limits for the above referenced 3 speed zones.

DESCRIPTION FOR EACH PROPOSED SPEED LIMIT:

(A) Reducing Speed limits for Existing Speed Zones

- 1) **49th Street (V Street to Broadway):** This speed zone has a posted speed limit of 35 mph. Since the 85th percentile speed as indicated by an E&TS is 31.9 mph, the posted speed limit for this speed zone should be reduced to 30 mph.
- 2) **Fruitridge Road (Florin Perkins Road to South Watt Avenue):** This speed zone has a posted speed limit of 50 mph. Since the 85th percentile speed as indicated by an E&TS is 46.9 mph, the posted speed limit for this speed zone should be reduced to 45 mph.
- 3) **Mabry Drive (Maybrook Way to Natomas Boulevard):** This speed zone has a posted speed limit of 30 mph. Since the 85th percentile speed as indicated by an E&TS is 28.1 mph, the posted speed limit for this speed zone should be reduced to 25 mph.

(B) Re-establishing Speed Limits for Existing Speed Zones

- 1) **2nd Avenue (Stockton Boulevard to 49th Street):** This zone has a posted speed limit of 30 mph. Since the 85th percentile speed as indicated by an E&TS is 30.1 mph, the posted speed limit for this speed zone should be re-established at 30 mph.
- 2) **12th Street (North B Street to F Street):** This zone has a posted speed limit of 30 mph. Since the 85th percentile speed as indicated by an E&TS is 29.7 mph, the posted speed limit for this speed zone should be re-established at 30 mph.
- 3) **21st Avenue (Franklin Boulevard to Martin Luther King Jr. Boulevard):** This zone has a posted speed limit of 30 mph. Since the 85th percentile speed as indicated by an E&TS is 31.4 mph, the posted speed limit for this speed zone should be re-established at 30 mph.
- 4) **21st Avenue (Stockton Boulevard to 79th Street):** This speed zone has a posted speed limit of 35 mph. Since the average 85th percentile speed as indicated by four E&TS is 34.3 mph, the posted speed limit for this speed zone should be re-established at 35 mph.

- 5) **Alhambra Boulevard (C Street to Broadway)**: This speed zone has a posted speed limit of 30 mph. Since the average 85th percentile speed as indicated by three E&TS is 30.3 mph, the posted speed limit for this speed zone should be re-established at 30 mph.
- 6) **Arden-Garden Connector**: This speed zone has a posted speed limit of 50 mph. Since the average 85th percentile speed as indicated by two E&TS is 48.8 mph, the posted speed limit for this speed zone should be re-established at 50 mph.
- 7) **Duckhorn Drive (Northgate Boulevard to Colfax Street)**: This zone has a posted speed limit of 35 mph. Since the 85th percentile speed as indicated by an E&TS is 34.1 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 8) **El Camino Avenue (East Levee Road to Del Paso Boulevard)**: This speed zone has a posted speed limit of 30 mph. Since the average 85th percentile speed as indicated by two E&TS is 33.8 mph, the posted speed limit for this speed zone should be re-established at 30 mph.
- 9) **El Camino Avenue (Del Paso Boulevard to Ethan Way)**: This speed zone has a posted speed limit of 35 mph. Since the average 85th percentile speed as indicated by two E&TS is 36.9 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 10) **Folsom Boulevard (Alhambra Boulevard to Elvas Avenue)**: This speed zone has a posted speed limit of 35 mph. Since the average 85th percentile speed as indicated by four E&TS is 35.1 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 11) **Franklin Boulevard (Fruitridge Road to South of 38th Avenue)**: This speed zone has a posted speed limit of 40 mph. Since the 85th percentile speed as indicated by an E&TS is 40.1 mph, the posted speed limit for this speed zone should be re-established at 40 mph.
- 12) **Fruitridge Road (South Land Park Drive to Martin Luther King Jr. Boulevard)**: This speed zone has a posted speed limit of 40 mph. Since the average 85th percentile speed as indicated by three E&TS is 40.6 mph, the posted speed limit for this speed zone should be re-established at 40 mph.
- 13) **Fruitridge Road (Power Inn Road to Florin-Perkins Road)**: This speed zone has a posted speed limit of 45 mph. Since the 85th percentile speed as indicated by an E&TS is 43.2 mph, the posted speed limit for this speed zone should be re-established at 45 mph.

- 14) J Street (42nd Street to 56th Street):** This speed zone has a posted speed limit of 35 mph. Since the average 85th percentile speed as indicated by two E&TS is 35.7 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 15) La Riviera Drive (College Town Drive to Watt Avenue):** This speed zone has a posted speed limit of 35 mph. Since the 85th percentile speed as indicated by an E&TS is 36.7 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 16) Leisure Lane (Canterbury Road to Royal Oaks Drive):** This speed zone has a posted speed limit of 30 mph. Since the 85th percentile speed as indicated by an E&TS is 32.3 mph, the posted speed limit for this speed zone should be re-established at 30 mph.
- 17) Lemon Hill Avenue (East of Lucero Drive to Stockton Boulevard):** This speed zone has a posted speed limit of 35 mph. Since the 85th percentile speed as indicated by an E&TS is 35.2 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 18) Longview Drive (Roseville Road to Watt Avenue):** This speed zone has a posted speed limit of 40 mph. Since the 85th percentile speed as indicated by an E&TS is 39.6 mph, the posted speed limit for this speed zone should be re-established at 40 mph.
- 19) Main Avenue (Kelton Way to Rio Linda Boulevard):** This speed zone has a posted speed limit of 40 mph. Since the 85th percentile speed as indicated by an E&TS is 41.6 mph, the posted speed limit for this speed zone should be re-established at 40 mph.
- 20) Arcade Boulevard (Del Paso Boulevard to Connie Drive):** This speed zone has a posted speed limit of 35 mph. Since the 85th percentile speed as indicated by an E&TS is 35 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 21) Marconi Avenue (Connie Drive (W) to Howe Avenue):** This speed zone has a posted speed limit of 40 mph. Since the 85th percentile speed as indicated by an E&TS is 39.6 mph, the posted speed limit for this speed zone should be re-established at 40 mph.
- 22) Natomas Boulevard (Elkhorn Boulevard to Del Paso Road):** This speed zone has a posted speed limit of 45 mph. Since the 85th percentile speed as indicated by an E&TS is 44.6 mph, the posted speed limit for this speed zone should be re-established at 45 mph.

- 23) North B Street (Bannon Street to North 16th Street):** This speed zone has a posted speed limit of 35 mph. Since the 85th percentile speed as indicated by an E&TS is 36.6 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 24) Norwood Avenue (Grand Avenue to Fairbanks Avenue):** This speed zone has a posted speed limit of 35 mph. Since the 85th percentile speed as indicated by an E&TS is 37.4 mph, the posted speed limit for this speed zone should be re-established at 35 mph.
- 25) Norwood Bypass (Norwood Avenue to Grove Avenue):** This speed zone has a posted speed limit of 30 mph. Since the 85th percentile speed as indicated by an E&TS is 34 mph, the posted speed limit for this speed zone should be re-established at 30 mph.
- 26) Redding Avenue (Q Street to 850-ft North of San Joaquin Street):** This speed zone has a posted speed limit of 30 mph. Since the 85th percentile speed as indicated by two E&TS is 31.4 mph, the posted speed limit for this speed zone should be re-established at 30 mph.
- 27) Rush River Drive (Gloria Drive to Windbridge Drive):** This speed zone has a posted speed limit of 35 mph. Since the 85th percentile speed as indicated by an E&TS is 36.5 mph, the posted speed limit for this speed zone should be re-established at 35 mph.

RE-ESTABLISHING AND REDUCING SPEED LIMITS ON VARIOUS STREETS AND REPEALING RESOLUTION NO. 2013-0326

BACKGROUND

- A. Since an E&TS is usually valid for a period of 7 years, the City must update the E&TS for existing speed zones prior to their expiration date. Additionally, the City is required to reevaluate the speed limits on segments of the roadways that have undergone a significant change in roadway characteristics or surrounding land uses.
- B. In order to ensure compliance with the requirements set forth in the CVC, an E&TS have been performed for 30 speed zones on various streets of the City. These 30 speed zones include:
- (I) Re-establishing the speed limit for 27 speed zones; and
 - (II) Reducing speed limits for 3 speed zones.

A summary of the 85th percentile and proposed speed limits based on an E&TS for each of these 30 speed zones is presented in Exhibit A.

- C. The E&TS for justifying the proposed speed limits were performed in accordance with the requirements set forth in the CVC, California MUTCD, and established traffic engineering practices.
- D. Based on the background information presented herein, Staff recommends that the City Council adopt a resolution reducing and re-establishing speed limits on 30 speed zones set forth in Exhibit A.

- E. The previously adopted Council Resolution No. 2013-0326 for the citywide posted speed limits will need to be rescinded and superseded with a new resolution in order to incorporate the recommended speed limits for the above referenced 30 speed zones.
- F. A list of citywide speed limits that is recommended to be adopted as part of this City Council Resolution is presented in Exhibit B.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. Pursuant to California Vehicle Code sections 32 (“Actions Local Authorities May Take by Resolution”), 627 (“Engineering and Traffic Survey”), 22352 (“Prima Facie Speed Limits”), 22354.5 (“Speed Limit Change: Consultation and Consideration Requirements”), 22357 (“Increase of Local Speed Limits to 65 Miles Per Hour”), and 22358 (“Decrease of Local speed Limits”), the following declared prima facie speed limits (and maximum speed limits) have been established with Engineering and Traffic Surveys and are established as shown in Exhibit A: Summary of Engineering and Traffic Surveys and Proposed Speed Limits; and Exhibit B: Citywide Posted Speed Limits.
- Section 2. Resolution Number 2013-0326 is hereby rescinded.
- Section 3. Exhibits A and B are hereby incorporated into and are a part of this Resolution.
