Description/Analysis

Issue Detail: Accepting the election results as certified by the County Registrar of Voters will enter the vote into the official record of the City and allow certification of the ballot measure vote.

Policy Considerations: This action is consistent with California Elections Code and the Sacramento City Charter.

Economic Impacts: None.

Environmental Considerations: None.

Sustainability: None.

Commission/Committee Action: None.

Rationale for Recommendation: The City of Sacramento held a Special Vote by Mail Election on June 2, 2015, for the purpose of imposing a special tax pertaining to the Sacramento Streetcar Community Facilities Districts 2015-01. That Measure B was also known as the Sacramento Streetcar Election. Pursuant to the results contained in the Certificate of Facts (Exhibit A to the Resolution), the number of votes received in support of Measure B (Sacramento Streetcar Election) was less than the 2/3 requirement; therefore, the measure is defeated.

Financial Considerations: The County has not yet invoiced the City of Sacramento for the costs incurred to conduct the June 2, 2015 election. A cost estimate in the amount of \$55,548.00 was provided by the County.

Local Business Enterprise (LBE): None.

BACKGROUND:

The Special Vote by Mail Election has occurred, the County Registrar has certified the results, and the City Clerk has received the official "Certificate of Facts" (Exhibit A to the Resolution). As contained in the Certificate of Facts, pursuant to the results contained in the Certificate of Facts (Exhibit A to the Resolution), the number of votes received in support of Measure B (Sacramento Streetcar Election) was less than 2/3 vote; therefore, the measure is defeated.

Adopting the resolution accepting the election results is the final action that completes the June election.

Adopted by the Sacramento City Council

RECITING THE FACTS OF THE SPECIAL VOTE BY MAIL ELECTION HELD ON JUNE 2, 2015; DECLARING THE RESULTS; AND OTHER SUCH MATTERS AS PROVIDED BY LAW

BACKGROUND

- A. A Special Vote by Mail Election was held and conducted in the City of Sacramento, California on Tuesday, June 2, 2015 as required by law.
- B. Notice of the election was given in the time, form, and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received, and canvassed and the returns made and declared in time, form, and manner as required by the provisions of the Election Code of the State of California.
- C. Pursuant to Resolution No. 2015-0053, adopted February 24, 2015, the Sacramento County Office of Voter Registration and Elections canvassed the returns of the election and has certified the results to this City Council; the results are received, attached, and made part hereof as Exhibits A and B.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. That the whole number of ballots cast in the City was 1,335.
- Section 2. That the measure voted upon at the election and votes received was as follows:

Measure B - Pertaining to Formation of the Sacramento Streetcar Community Facilities District No. 2015-01, City of Sacramento, County of Sacramento, State of California

“Shall the Sacramento City Council, acting through the Sacramento Streetcar Community Facilities District No. 2015-01, City of Sacramento, County of Sacramento, State of California (the “CFD”), be authorized to incur debt with a principal amount not exceeding \$38,000,000 and to annually levy a special tax within the CFD to finance the
