Description/Analysis

Issue Detail: Staff recommends Council approve a construction contract with Florez Paving to install six new residential sewer services with cleanouts to connect to existing in-street combined sewer mains, and abandon approximately 200 feet of existing 4-inch and 6-inch diameter backyard sewer main that is failing.

Policy Considerations: Improvements to the aging and deteriorated sewer collection system is consistent with the Department of Utilities (DOU) Capital Improvement Programming Guide to provide safe, reliable collection and conveyance of wastewater. The requested action is in conformance with City Code Chapter 3.60, Articles I and III, which provide that the City Council may award competitively bid contracts to the lowest responsible bidder. Staff will verify, prior to the Notice to Proceed, that the bonds and insurance required for this project are valid.

Economic Impacts: This infrastructure replacement project is expected to create 0.428 total jobs (0.246 direct jobs and 0.182 jobs through indirect and induced activities) and create \$66,066 in total economic output (\$41,642 of direct output and another \$24,424 of output through indirect and induced activities).

The indicated economic impacts are estimates calculated using a calculation tool developed by the Center for Strategic Economic Research (CSER). CSER utilized the IMPLAN input-output model (2009 coefficients) to quantify the economic impacts of a hypothetical \$1 million of spending in various construction categories within the City of Sacramento in an average one-year period. Actual impacts could differ significantly from the estimates and neither the City of Sacramento nor CSER shall be held responsible for consequences resulting from such differences.

Environmental Considerations: The Community Development Department, Environmental Planning Division, has reviewed the proposed project and has determined that this project is categorically exempt from the California Environmental Quality Act (CEQA) under Class 1 and 2, Section Numbers 15301 and 15302 of the CEQA Guidelines. In an effort to meet the current standards of public health and safety, this project consists of rerouting residential sewer services away from existing deteriorated backyard sewer main to in-street combined sewer mains. The new residential sewer services will be located on private property and will be connected to an existing main and will have substantially the same purpose and capacity of the services replaced.

Sustainability: The project is consistent with the City's Sustainability Master Plan by reducing sanitary sewer outflows, which is one of the City's sustainability targets; and by improving reliability, which will reduce energy-intensive maintenance efforts.

Commission/Committee Action: Not applicable.

Rationale for Recommendation: The project was formally advertised on March 11, 2016 to solicit public bids. The City Clerk’s Office received and opened the following two bids on April 6, 2016:

Contractor	Bid Amount
Florez Paving	\$107,000
Navajo Pipelines	\$156,200

The engineer’s estimate was \$96,000. The lowest bidder is approximately 11% higher than the engineer’s estimate.

Financial Considerations: With a construction cost for an amount not-to-exceed \$107,000, the total costs for design, inspection, and construction are estimated to be \$184,480. Sufficient funding is available in the Combined Sewer System Capital program (X14010000) to award the contract and complete the project.

Local Business Enterprise (LBE): Florez Paving is an LBE.

Background

The existing 6-inch diameter vitrified clay pipe (VCP) selected for this contract is located in the backyard/side yard of residential properties north of J Street and west of 33rd Street. Frequent maintenance has been conducted and multiple SSOs have occurred due to the condition of this sewer main. Field crews inspected these segments and found significant root intrusion, severe cracks, fractures, and two sections of broken pipe where voids and soil are visible.

During the initial assessment, Department of Utilities (DOU) engineering staff considered trenchless methods such as pipe lining or pipe bursting. However, it was discovered that the sewer main is fairly shallow, that there are two garages over the sewer main, and that there is no public utility easement. These conditions make a sewer CIP with trenchless methods extremely complex and challenging. In order to provide the most reliable sewer service to homeowners, DOU engineering staff decided to reroute the sewer laterals to the combined sewer mains in 33rd and J streets. Rerouting of the sewer laterals and abandonment of this sewer main will benefit both the City maintenance staff and the homeowners. Abandoning this sewer main will eliminate frequent maintenance and significantly decrease the occurrence of sanitary sewer overflows.
