**4. Ordinance Amendment: Living Wage and Prevailing Wage**

Reviewed an Ordinance amending City Code section 3.58.030 pertaining to the payment of a living wage and repeal City Code section 3.56.070 pertaining to the payment of prevailing wages, to establish a single authority for regulating the wage rates and optional health benefit standards for employees of contractors performing services classified as non-professional services, and reenacting section 3.56.070 to extend the 60 day transition employment period for janitors set forth in Labor Code §1061 to 90 days and public comment was heard from Bill Camp and Lino Pedres.
