Title: Ordinance Amending Section 12.16.180 of the Sacramento City Code
Concerning Temporary Street Closures

Recommendation: Staff recommends that the Committee approve and forward to the City Council the attached amendments to Title 12 of the City Code.

Description/Analysis:

Issue: The California Vehicle Code Section 21101.4 allows local jurisdiction to temporarily close streets with continual criminal activity. In 1996, Section 21101.4 was amended to extend the initial closure for up to five consecutive periods of 18 months. In 2007, Section 21101.4 was again amended to allow local jurisdiction to extend the closure for not more than eight consecutive periods of 18 months. City Code Chapter 12.16, Article II, was enacted in 1999 pursuant to authority of vehicle code section 21101.4. It currently allows for an initial 18 month closure period and five consecutive extensions.

Policy Considerations: The proposed ordinance amendment is consistent with the City of Sacramento Strategic Plan goals of improving and expanding public safety, and achieving sustainability and enhancing livability.

Environmental Considerations:

California Environmental Quality Act (CEQA): The Environmental Planning Services section of the Development Services Department has reviewed the proposed amendment and has determined that the activity is exempt from the provisions of the California Environmental Quality Act


(CEQA) under Section 15301(f) of the CEQA Guidelines. This action involves general policy of temporary closures of existing alleys by adding gates as restrictive devices to problem alleys. This action will not create any adverse impacts on the environment.


Committee/Commission Action: None.

Rationale for Recommendation: The City Code amendment is necessary for the effectiveness of the Problem Alley Abatement Program over a longer time period.



Attachment 1**Background:**

Currently the City of Sacramento has a Problem Alley Abatement Program which allows citizens to formally request the temporary closure of streets and alleys for the benefit of public safety. Authority for the temporary closure of streets is derived from the California Vehicle Code Section 21101.4 which authorizes local jurisdictions to temporarily close streets for a initial 18 months. In 1996, Section 21101.4 was amended to allow local jurisdictions to extend the initial closure for up to five consecutive periods of 18 months, if prior to each extension, a public hearing was held and the specified conditions were found to exist. In 2007, Section 21101.4 was again amended to allow local jurisdictions to extend the closure for not more than eight consecutive periods of 18 months, if prior to each extension, a public hearing is held and the specified conditions are found to exist. City Code Chapter 12.16, Article II, was enacted in 1999 pursuant to authority of vehicle code Section 21011.4. It currently allows for an initial 18 month closure period and five consecutive extensions.

This report recommends that the Council adopt the attached Ordinance amending section 12.16.180 of the City Code concerning temporary street closures to increase the maximum number of extensions from 5 consecutive renewals to eight consecutive renewals. The amendment will allow the City to make full use of full temporary closure period allowed by the California Vehicle Code.
