

Statement of Interest for Sacramento City/County Bicycle Advisory Committee

I believe my experience would be an excellent addition to the Sacramento City/County Bicycle Advisory Committee. I am a cyclist with knowledge of policymaking, transportation planning, and bike infrastructure. I understand the needs of transportation users from various age groups and demographics. I am comfortable sharing my views, asking questions and working with a diverse group of people. I would be thrilled to take part in the process of implementing the Bicycle Master Plan.

In Santa Cruz, I created and implemented a grant-funded program to educate high school students and community members about the health, environmental and financial benefits of choosing sustainable transportation. In my two years as Program Director of the Green Ways to School Program, I was involved in transportation planning and policy issues. I worked directly with schools, law enforcement, local policy makers and activists. During my tenure we observed a marked increase in youth involvement in city planning and made significant progress on several bike infrastructure projects.

I worked with City Council members, city planners and concerned citizens to balance the multiple needs present: safety of cyclists, pedestrians, and people with mobility devices, limits of existing infrastructure, budgeting constraints, existing law and political feasibility of proposals. I learned a great deal about research, outreach and finding solutions. I have a background in conflict resolution, and developed a reputation for listening and working towards consensus.

Last year I moved to Sacramento to join the Capital Fellows Program. In my placement at the High Speed Rail Authority, I was exposed to policy discussion on a much different scale. My primary project was communicating with communities to develop guidelines for station area development, emphasizing the principals of smart growth and transit-oriented development. In my current position conducting outreach for the Secretary of State, I continue to develop my problem solving and communication skills while connecting with communities in Sacramento and across the state.

I plan to live in Sacramento long-term and wish to be a part of the process of this city's development. I predict that Sacramento can be an example of a city that makes transportation safe, accessible and enjoyable for all types of transportation users. I believe my experience, skills and attitude would be a valuable addition to the Sacramento City/County Bicycle Advisory Committee.




