Summary:

The attached resolution will amend Resolution 2005-330 authorizing the Procurement Services Manager to purchase Verizon and Sprint/Nextel cellular phone services through the State of California's Wireless Contract (contract #1S-05-58-01/02) for purchase made in Fiscal Year 2005/06. The previous contract through the Western States Contracting Alliance (WSCA) has expired and will not be renewed by the State of California. The State issued a bid for wireless services and a contract was awarded to Verizon and Sprint/Nextel. The authorized purchase amount will not be increased.

Background Information:

In May 2005, City Council approved the purchase of cellular phone services for a total amount not-to-exceed \$1,500,000 under WSCA contracts for the following vendors:

- AT&T/Cingular (WSCA Master Price Agreement No. 10-00115);
- Nextel (WSCA Master Price Agreement No. 12-00115); and
- Verizon (WSCA Master Price Agreement No. 11-00115)

The WSCA contracts for Verizon and Nextel have expired and will not be renewed by the State of California. The State issued a bid for wireless services and a contract was awarded to Verizon and Sprint/Nextel (contract #1S-05-58-01/02). Under the provisions of this contract, the City is authorized to use this contract. The WSCA contract for AT&T/Cingular is still valid until June 30, 2006. The time and effort savings achieved by using a Cooperative Purchasing Agreement is a substantial benefit to the City.

Financial Considerations:

No additional funding authorization is requested. The funding for cellular phone services, equipment and the mobile device synchronization project in the amount of \$1,500,000 will come from each City Department's Fiscal Year 2006 budgets.



AMENDING RESOLUTION 2005-330 AUTHORIZING THE PROCUREMENT SERVICES MANAGER TO PURCHASE VERIZON AND SPRINT/NEXTEL CELLULAR PHONE SERVICES THROUGH THE STATE OF CALIFORNIA'S WIRELESS CONTRACT (CONTRACT #1S-05-58-01/02) FOR PURCHASES MADE IN FISCAL YEAR 2005/06

BACKGROUND

- A. In May 2005, City Council approved the purchase of cellular phone services for a total amount not-to-exceed \$1,500,000 under WSCA contracts for the following vendors:
- AT&T/Cingular (WSCA Master Price Agreement No. 10-00115);
 - Nextel (WSCA Master Price Agreement No. 12-00115); and
 - Verizon (WSCA Master Price Agreement No. 11-00115)
- B. The WSCA contracts for Verizon and Nextel have expired and will not be renewed by the State of California. The State issued a bid for wireless services and a contract was awarded to Verizon and Sprint/Nextel (contract #1S-05-58-01/02). Under the provisions of this contract, the City is authorized to use this contract. The WSCA contract for AT&T/Cingular is still valid until June 30, 2006. The time and effort savings achieved by using a Cooperative Purchasing Agreement is a substantial benefit to the City.
- C. No additional funding authorization is requested. The funding for cellular phone services, equipment and the mobile device synchronization project in the amount of \$1,500,000 will come from each City Department's Fiscal Year 2006 budgets.
