Adopt the attached resolution authorizing the City Manager, or his designee, to execute the nonprofessional services agreement for Crack Sealing at Various Locations with Bond Blacktop Inc. in an amount not to exceed \$250,000 annually.

Summary:

The Street Services Division requires crack sealing in preparation for the annual seal coat and overlay program. This project was formally advertised and bid. Five bids were received. Staff recommends award to Bond Blacktop Inc., the lowest, responsive bidder.

Background Information:

- Crack sealing is a process required in preparation for the City's annual seal coat and overlay program. The Street Services' contract for crack sealing streets includes various locations throughout the City that are already identified for the next annual street-resurfacing program.

- The Street Services Operation budget annually allocates \$250,000 for the delivery of street crack sealing maintenance.
- This project was formally advertised and bid. Bids were received by the City Clerk's office on May 31, 2006. The bid amount is based on 120 tons of crack seal product applied. Bid summary is below.

- Award to Bond Blacktop Inc. is recommended as the lowest responsive bidder.
- This agreement may be extended, if mutually agreeable, for four additional years.

Financial Considerations:

There are adequate funds in the Street Services budget for this work.

Environmental Considerations:

This project has been determined to be exempt from the California Environmental Quality Act (CEQA) under section 15301 (c) of the CEQA Guidelines, which states that repair and maintenance of existing highways and streets involving negligible or no expansion of existing use is exempt from CEQA review.

Policy Considerations:

The recommendations in this report are consistent with the City's Strategic Plan goals to improve and expand public safety, and achieve sustainability and livability.

Emerging Small Business Development (ESBD):

Bond Blacktop Inc. is using a subcontractor who is a certified Small Business Enterprise for 20% of the total work.

RESOLUTION AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO EXECUTE THE NONPROFESSIONAL SERVICES AGREEMENT FOR CRACK SEALING AT VARIOUS LOCATIONS WITH BOND BLACKTOP INC. FOR AN ANNUAL AMOUNT NOT TO EXCEED \$250,000.

BACKGROUND

1. Crack sealing is a process required in preparation for the City's annual seal coat and overlay program. Street Services' contract for crack sealing streets includes various locations throughout the City that are already identified for the next annual street-resurfacing program.
2. The Street Services Operation budget annually allocates \$250,000 for the delivery of street crack sealing maintenance.
3. This project was formally advertised and bid. Bids were received by the City Clerk's office on May 30, 2006. The bid amount is based on 120 tons of crack seal product applied. Bid summary is below:
