

RESOLUTION NO. 2006-797

SUNRISE SIDE CHANNEL PROJECT ON THE LOWER AMERICAN RIVER AS PART OF THE CALIFORNIA RIVER PARKWAYS GRANT PROGRAM UNDER THE WATER SECURITY, CLEAN DRINKING WATER, COASTAL AND BEACH PROTECTION ACT OF 2002 (PROPOSITION 50)

BACKGROUND

- A. The Legislature and Governor of the State of California have provided Funds for the California River Parkways Grant Program under the water security, clean drinking water, coastal and beach protection act of 2002 (proposition 50). The projected total cost of this project is \$695,993. The Water Forum's cost share amount is expected to be \$69,658 and is available in Fund 514 for the Habitat Management Element; and
- B. The Resources Agency has been delegated the responsibility for the administration of this grant program, establishing necessary procedures; and
- C. Said procedures established by the State Resources Agency require a resolution certifying the approval of applications by the Applicant's governing board before submission of said application to the State; and
- D. The Applicant, if selected, will enter into an agreement with the State of California to carry out the Project; and
- E. The City-County Office of Metropolitan Water Planning (CCOMWP) has developed an application for the Sunrise Side Channel Project on the American River that is designed to protect steelhead redds in the project area from drying up during river fluctuations; and
- F. The Sunrise Side Channel Project will enhance the production of wild spawning steelhead in the lower American River by preventing the dewatering and dessication of steelhead redds at this site

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City-County Office of Metropolitan Water Planning (CCOMWP) is authorized to file an application for the Sunrise Side Channel Project;

- Section 2. The City Council of Sacramento certifies that Applicant understands the assurances and certification in the application, and
- Section 3. Certifies that Applicant or title holder will have sufficient funds to operate and maintain the Project consistent with the land tenure requirements, or will secure the resources to do so, and
- Section 4. Certifies that it will comply with the provisions of Section 1771.8 of the State Labor Code regarding payment of prevailing wages on projects awarded Proposition 50 Fund, and
- Section 5. If applicable, certifies that the project will comply with any laws and regulations including, but not limited to, legal requirements for building codes, health and safety codes, disabled access laws, and, that prior to commencement of construction, all applicable permits will have been obtained, and
- Section 6 Authorizes the Program Manager of the City-County Office of Metropolitan Water Planning (CCOMWP), or designee, as agent to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements, payment requests and so on, which may be necessary for the completion of the aforementioned Project,
