**Title:** Pregnancy Prevention Program Agreement

### **Description/Analysis**

**Issue:** The County of Sacramento has again asked the Parks and Recreation Department to operate a pregnancy prevention program at the Pannell Meadowview Community Center. Authorization is required to continue the program through Fiscal Year 2009 and for the City Manager to sign the agreement and any amendments or extensions.

**Policy Considerations:** Continued participation in this program is consistent with the City's strategic plan to enhance livability.

**Environmental Considerations:** None

**Commission/Committee Action:** None

**Rationale for Recommendation:** Continued operation of a pregnancy prevention program will enable the City to continue partnering with the County of Sacramento's Department of Health and Human Services in providing needed services to a targeted audience. Revenue received from the County covers all costs of the program, ensuring that no General Fund support is required.



**Financial Considerations:** The program is funded through June 30, 2009, by the County of Sacramento in the amount of \$17,958 per year. Because this is a continuation of a program that operated in Fiscal Year 2006, no appropriation or budget amendment is needed. No General Fund support is required.

**Emerging Small Business Development (ESBD):** Purchase of supplies and equipment will be made in accordance with the City's Emerging and Small Business Development program requirements.

## **Attachment 1**

### **Background**

The Department of Parks and Recreation has operated the Pregnancy Prevention Program on behalf of the County of Sacramento's Department of Health and Human Services for one year under a prior agreement. The pending agreement with the County would authorize the continuation of the program for three years, through June 30, 2009.

The program's services are directed at youth ages 12 to 14. During the school year, the services would be provided at the Pannell Meadowview Community Center to a minimum of 20 youths for one hour per week for 36 weeks. Topics to be covered with the youth include values, human development, relationships, choices, sexuality and decision-making. The County has specified the curriculum to be used, which was purchased in the first year. The youth also will be involved in at least one volunteer or service learning activity each month.

The youth will be tested at the beginning and the end of the program to determine their knowledge of the topics and their attitudes and opinions relating to sex and pregnancy prevention.

Council authorization is requested to continue the program through June 30, 2009.

**PREGNANCY PREVENTION PROGRAM AGREEMENT APPROVAL**

**BACKGROUND**

- A. The Department of Parks and Recreation has operated a pregnancy prevention program on behalf of the County of Sacramento's Department of Health and Human Services for one year at the Pannell Meadowview Community Center under a prior agreement. The County has asked the Department to continue operating the program. The pending agreement with the County would authorize the continuation of the program for three years, through June 30, 2009.
- B. Continued operation of the pregnancy prevention program will enable the City to continue partnering with the County in providing needed services to an audience targeted by the County.
- C. The program is funded by the County of Sacramento. Because this is a continuation of a program that operated in Fiscal Year 2006, no appropriation or budget amendment is needed.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. The Department of Parks and Recreation is authorized to continue operating a pregnancy prevention program on behalf of the County of Sacramento through June 30, 2009.
- Section 2. The City Manager is authorized to sign all agreements and documents, including any extensions, amendments or re-applications thereto, with the County of Sacramento as necessary for the City to continue to operate for the County a pregnancy prevention program for youth.
