**Environmental Considerations:** Not applicable. The California Environmental Quality Act (CEQA) does not apply.



**Background**

The Sacramento City Treasurer's Office is a Charter Office providing a wide variety of services to the City of Sacramento. The annual report reflects the work performed by the City Treasurer's Office during the Fiscal Year 2005-2006.

Thomas P. Friery was appointed to the Charter Position of City Treasurer in 1978 and has served in this position for the last 28 years. His leadership in matters of Investments, Financings and Special Projects has allowed the City of Sacramento to enjoy its current fiscal well being and has contributed to the City's high grade investment ratings.

The report includes the significant accomplishments, statistical information and past performance for our two (2) Business Units, Investment & Operations Unit and the Public Finance & Banking Unit as well as the Administrative/Special Projects Unit.

In 1978 The City Treasurer was charged with providing independent checks and balances for the City of Sacramento. That service been provided to Mayor and Council for the past 28 years, as directed. This "independent check and balance" has kept the City of Sacramento from following in the footsteps of other local municipalities such as City of San Jose, Orange County, City of San Diego, etc, who had no such advantage.

The Sacramento City Treasurer's Office plays a vital role in the City's efforts to promote safety, livability and economic vitality. Included in the Annual Report is the Mission Statement for the City Treasurer's Office as well as the goals and objectives for Fiscal Year 2006-2007.
