

RESOLUTION NO. 2007-120

Adopted by the Sacramento City Council

February 27, 2007

CITYWIDE FEES AND CHARGES REVIEW AND ONLINE DATABASE

BACKGROUND:

- A. On February 7, 2006, the City Council adopted the Citywide Fees and Charges policy (Resolution No. 2006-106).
- B. Implementation of the policy requires a necessary mechanism to ensure that the City's fees and charges reflect the City's current costs and that those fees and charges are reviewed on an annual basis by City Council.
- C. Fees currently charged by Departments are set forth in Exhibit A. Proposed new fees and fee changes are set forth in Exhibit B.



Justification: These fees covers costs of City Attorneys serving as issuers counsel in the issuance bonds issued to refund outstanding bonds. Among other things, the deputy assigned to the transaction attends all meetings; drafts and reviews resolutions, agreements, official statements, title reports, and other documents; prepares and signs opinion of issuers counsel; and provides legal advice as needed. The volume of work on refunding bonds is typically equal to the volume of work on the bonds initially issued; hence, the fees for refunding bonds should be the same as those for issuance of the bonds being refunded.

Fee Name: Development Related - Legal Service Fee

Current Fee: \$95-\$100 hourly rate based on actual attorney time

Proposed Fee: \$142 hourly rate based on current blended rate for senior attorneys

Justification: This hourly rate is for legal review of development related agreements (for areas other than North Natomas). The rate is updated to reflect the current blended hourly rate as determined by a detailed cost analysis from the Accounting Division for senior attorneys (includes classifications: Senior Deputy City Attorney, Supervising Deputy City Attorney, Assistant City Attorney and City Attorney).

Fee Name: Financing Agreements: Issuance of certificates of participation - Legal Review Fee

Current Fee: None; this is a new fee

Proposed Fee: \$14,500

Justification: This fee covers costs of City Attorneys serving as issuers counsel in the issuance of certificates of participation, or COP's, in connection with the financing of public improvements. Among other things, the deputy assigned to

the transaction attends all meetings; drafts and reviews resolutions, agreements, official statements, title reports, and other documents; prepares and signs opinion of issuers counsel; and provides legal advice as needed. City Attorney does not currently charge a fee for the review of COP's but it equivalent to the volume of work typically performed on CIRB's; hence, the fees for these two types of transactions should be the same.

Finance Department

Fee Name: Vehicle Driver Permit Renewal Fee

Current Fee: \$75.00 (biennially)

Proposed Fee: \$75.00 (yearly)

Justification: Resolution 2006-336 established this fee to be levied upon taxicab drivers to renew their permits to drive taxicabs. The resolution incorrectly listed the renewal fee as a biennial fee instead of an annual fee.

Fee Name: Fingerprint Fee

Current Fee: \$60.00

Proposed Fee: \$59.50

Justification: The fingerprint fee is charged to taxicab drivers for purposes of running background checks prior to issuing their taxicab permit. The fingerprint fee reduction by 50 cents is to bring it into alignment with fingerprint fees charged by other City departments.

Fee Name: Vehicle Driver Permit Fee

Current Fee: \$250.00

Proposed Fee: \$150.00

Justification: This is an annual fee charged to the owner of a taxicab allowing them to operate the taxicab. Resolution 2006-336 established the vehicle permit fee with two parts: 1) \$150.00 fee for the vehicle permit; and 2) \$100.00 inspection fee. The proposed fee removes the inspection fee because taxicab drivers pay the fee directly to Paratransit to perform the inspection. Since the inception of this fee, the City has never collected the full \$250.00 Vehicle Permit Fee, but rather collected \$150.00 for this fee, recognizing that the \$250.00 amount was an error.

Fee Name: Vehicle Inspection Fee

Current Fee: \$85.00

Proposed Fee: \$100.00 (paid directly to Paratransit)

Justification: This is an annual fee charged to the taxicab operator to inspect the taxicab for safety and operational issues. The proposed fee corrects the standalone fee amount and notes that the fee is paid directly to Paratransit and not the City. The vehicle must pass inspection by Paratransit before the City issues the vehicle driver permit.

Police Department

Fee Name: Photo CD Fee

Current Fee: \$15.00 - an additional \$3.00 if images do not fit on 1 CD

Proposed Fee: \$26.00 – an additional \$4.00 if images do not fit on 1 CD

Justification: In 2006, Police Forensics provided 1,911 CDs containing photos from accidents, major crime scenes, and injuries to requestors including attorneys and insurance companies. The Police Department proposes to charge \$26.00 per CD (\$4.00 per additional CD) to cover the direct cost of the CD, case, printer usage, ink cartridges, and staff time for making duplication. These costs are in accordance with the City Attorney's legal opinion.

Fee Name: Secondhand/Pawn Dealer Permit

Current Fee: None

Proposed Fee: \$120.00

Justification: City Code 5.80 requires junk dealers, secondhand dealers, pawnbrokers, or pallet resellers to secure a permit. According to the code it is unlawful and a public nuisance for any person to conduct or operate such a business without a permit. There has never been an administration fee due to low permit volume. The Police Department has recently seen an increase in permit activity and several hours of staff time are involved in issuing one of these permits. The proposed fee is based on actual cost to perform background checks, history on location, communications with Department of Justice and City Revenue, creation of permit, maintenance and update of database, and review of surety bond.

Fee Name: Secondhand/Pawn Dealer Permit Renewal

Current Fee: \$25.00

Proposed Fee: \$75.00

Justification: City Code 5.80 requires junk dealers, secondhand dealers, pawnbrokers, or pallet resellers to renew their permit on an annual basis. Fee increase is based on actual cost – labor plus overhead. Labor includes the cost of reviewing background checks, coordinating efforts with Department of Justice, history on location, creation of permit, maintenance and update of database, and review of surety bond. Fee also includes the cost of mailing documents, I.T. and other costs associated with phone, fax, and internet, cost of files including folders, and labels.

Parks and Recreation

Input on the following fee recommendations for Parks and Recreation services was received through the September 2006 public survey and through outreach to the four Neighborhood Service Area Leadership groups. Fee increases were supported, especially if not doing so resulted in a reduction in services.

On February 1, 2007, the Parks and Recreation Commission approved a recommendation to City Council to consider a higher fee for regional park picnic and sports fields reservations than recommended by staff, due to heavier use at these facilities and therefore increased maintenance needs, and that regional facilities draw visitors from throughout the greater Sacramento area. The Commission supported all other fee recommendations.

The first four recommended fee increases related to park use would generate approximately \$65,000 in new annual revenue to help offset increased costs in a growing park system for Park Safety Services and utilities as follows:

Fee Name: Picnic Area Reservations - Community and Neighborhood Parks

Current Fee: \$15.00 per 50 guests full day

Proposed Fee: \$20.00 per 50 guests full day

Justification: The City's neighborhood and community park picnic area reservation fee remains well below neighboring jurisdictions and cost recovery for services is low (Citrus Heights: \$100; Elk Grove: \$50 to \$60; Rocklin: \$80).

Fee Name: Picnic Area Reservations - Regional Parks

Current Fee: \$30.00 per 50 guests for full day

Proposed Fee: \$50.00 per 50 guests for full day

Justification: With the Parks and Recreation Commission's recommendation to set a higher fee, staff recommendations an increase to \$50.00 per full day given larger events in the regional park system which require additional services. The City's regional park picnic area reservation fee remains well below neighboring jurisdictions and cost recovery for services is low (Citrus Heights: \$110; Elk Grove: \$150 to \$350; Sacramento County: \$125 - \$200).

Fee Name: Sports Field Reservations; Sports Field Lights - Community and Neighborhood Parks

Current Fee: Fields: For adults (youth are free): \$10 per hour. Field Lighting fee (applied to youth and adults): \$25 per hour and field use fee is waived

Proposed Fee: Fields: For adults (youth are free): \$14 per hour. Field Lighting fee (applied to youth and adults): Remain at \$25 per hour and cease practice of waiving field use fee when lights are used

Justification: The recommended fee remains below neighboring jurisdictions and cost recovery for services is low (Roseville: \$10 per hour youth; \$20 per hour adults; \$15 per hour for lights; Elk Grove: \$65 half day; \$130 full day; \$20 per hour for lights).

Fee Name: Sports Field Reservations; Sports Field Lights - Regional Parks
Current Fee: Fields: For adults (youth are free): \$18 per hour weekdays and \$28 per hour weekends. Field Lighting fee (applied to youth and adults): \$25 per hour and field use fee is waived

Proposed Fee: Fields: For adults (youth are free): \$22 per hour weekdays and \$34 per hour weekends. Field Lighting fee (applied to youth and adults): Remain at \$25 per hour and cease practice of waiving field use fee when lights are used.

Justification: The recommended fee remains at or below neighboring jurisdictions and cost recovery for services is low (Roseville: \$10 per hour youth; \$20 per hour adults; \$15 per hour for lights; Elk Grove: \$65 half day; \$130 full day; \$20 per hour for lights).

The next three recommended set of fees would generate \$14,000 in new annual revenue to help offset increased costs due to customer demand for special events in Sacramento as follows:

Fee Name: Street Closure Application: Community Events, Parades - Under 500 in attendance

Current Fee: \$25.00

Proposed Fee: \$50.00

Justification: Special Events has experienced a 50% growth level since 2000, from 600 to 900 events annually. To meet current demand, fee increases are recommended to help offset increased staff time necessary to review and permit events. Even with the proposed fee increase, the City's street closure application fee is well below other cities (Woodland: \$100; Stockton: \$228; San Jose: \$500 - \$1,300 depending on size of event).

Fee Name: Street Closure Application: Community Events, Parades - 500 - 3,000 in attendance

Current Fee: \$100.00

Proposed Fee: \$150.00

Justification: Special Events has experienced a 50% growth level since 2000, from 600 to 900 events annually. To meet current demand, fee increases are recommended to help offset increased staff time necessary to review and permit events. Even with the proposed fee increase, the City's street closure application fee is at or below other cities (Woodland: \$100; Stockton: \$228; San Jose: \$500 - \$1,300 depending on size of event).

Fee Name: Street Closure Application: Community Events, Parades - 3,001 or more in attendance

Current Fee: None

Proposed Fee: \$200.00

Justification: Special Events has experienced a 50% growth level since 2000, from 600 to 900 events annually. To meet current demand, fee increases are

recommended to help offset increased staff time necessary to review and permit events. With the proposed fee increase, the City's street closure application fee for large parades would result in low cost recovery (Woodland: \$100; Stockton: \$228; San Jose: \$500 - \$1,300 depending on size of event).

Fee Name: Neighborhood Block Party Application (permit to block residential street)

Current Fee: \$10.00

Proposed Fee: \$20.00

Justification: Special Events has experienced a 50% growth level since 2000, from 600 to 900 events annually. To meet current demand, fee increases are recommended to help offset increased staff time necessary to review and permit events. Even with the proposed fee increase, cost recovery for service is low.

Fee Name: Community Center Facility Rental

Current Fee: \$20.00 to \$90.00 per hour depending on size of room and if other facilities are used (kitchen, stage, etc.)

Proposed Fee: \$35.00 to \$150.00 per hour depending on size of room and if related facilities are used (kitchen, etc.)

Justification: Both operating costs and hours of operation have increased for the City's expanding community center system. Community Center room rental fees have not been adjusted since 1991. These increases would raise up to an additional \$60,000 annually to help offset rising operational costs including labor and utilities. Even with the proposed fee increase, the City's community center rental fee is at or below other area centers (Elk Grove: \$60 - \$150 per hour depending on size of room; Fulton/El Camino: \$75 to \$110 per hour depending on day of week).

Fee Name: E - Business Services Transaction Fee

Current Fee: None

Proposed Fee: \$3.00 per transaction (effective 3/1/07)

Justification: Customers have long requested the ability to book registrations for recreation services via the Internet, and have complained about limited access to Parks and Recreation's call center. To provide this service, new ongoing costs for technology services, licensing, telecommunications and banking fees will be \$50,000 annually, mostly technology services. Fee revenue is estimated at \$15,000 for FY 08, will partially offset the cost to implement and maintain this technology and would grow with projected increased use of the Internet registrations over time. Customers will still be able to book reservations through current methods. At \$3.00 per transaction, the City's fee is half of other comparable services (State Parks: Camping Reservations - \$7.50 processing fee; Sonoma Regional Parks: \$7 processing fee)

Planning Department

Fee Name: Special Districts Application Fee

Current Fee: \$5,000 regardless of the district type

Proposed Fee: \$7,500 for non-bond Districts; \$12,500 for bond Districts

Justification: The current fee was last changed in 1994 and is a means to cover staff and miscellaneous costs prior to actual formation of a district or an annexation to a district. This approach insures that preliminary costs will be paid if the district does not form or annex. If a district does form, the preliminary charge can be refunded with costs recovered from bonds or assessments, or the charge can be a credit against such bonds or assessments. Costs now average about \$7,500 for districts not involving bond financing and \$12,500 for districts with bonds. Costs not recovered are paid by the General Fund. The County currently charges \$12,500 for all district formations and annexations. The City of Elk Grove charges \$7,000. Roseville charges \$7,500 for districts not involving financing.

Proposed New Enterprise Fund Fees or Fee Increases

Convention, Culture, and Leisure - Sacramento Archives and Museum Collection Center

The Sacramento Archives and Museum Collection Center (SAMCC) houses both regional historical museum collections and public and private archives. Public archives include City, County and local special districts. SAMCC recommends the implementation of a fee increase for commercial duplication and reproduction of materials in its collection.

The fees and charges for duplication of materials in the SAMCC collection were last changed in 2004. Since then, increased use of new technologies, such as digital imaging and scanning, and on-line posting of Archives images, have expanded the types of services available to both the general public and commercial users. These new technologies have simultaneously increased demand for these services. In addition, the identification of markets for the licensed use of film and video has evolved with technology and market demand.

The increased fee revenue will recover the cost of extended staff time needed to reproduce materials and meet the challenges of the new technology. SAMCC's fees are substantially lower than their counterparts in Sacramento and other western cities and states. SAMCC staff does not recommend a change to the fees for private and non-profit use. A summary of specific proposed changes follows.

Utilities

The Department of Utilities is currently unable to recover costs for numerous miscellaneous water and sewer fees due to increased fuel and material costs, and increased labor costs.

Service costs for Tap installations have increased by an average of 18% over the last three years. Although labor rates went up, the overhead rate went down. Equipment costs went up due to fuel costs and replacement costs. Labor and equipment accounts for about 4% of the overall per year increase. The biggest fee increases appear in the larger tap installation because the prior fee analysis separated tap fees into only two categories; large and small. To allocate costs more equitably, tap fees have been separated into 3 categories; small medium and large. Because of this restructuring, the cost to install a medium size tap has gone down, while large tap installation costs have increased and reflects their true costs. Larger tap installations require additional labor and equipment to complete the work, which was not factored in previous studies. This fee restructuring more accurately reflects the true cost of services.

While the actual cost of meters have decreased due to volume discounts, the cost of installing a meter, in some cases, has increased. The cost of service for installation of an one-inch meter increased by 6% representing 83% of all water service installation while other size installations have decreased in cost due to reduced meter prices and efficiencies.

The proposed recommendations have been compared to other similar agencies and remain, in most cases within comparable levels. Several agencies that the department surveyed plan to examine their current rates and recommend increases to reflect their current costs of service.

Miscellaneous water fees were last updated in 2005; miscellaneous sewer fees were last updated in 1996. With the proposed fee structure, Water fees will increase by 8.5% (or 2.8% per year) since the last update and sewer fees will increase by 54% (or 4.9% per year) since the last update.

In order to continue providing the current service levels, the department recommends the following fee adjustments that reflect the estimated, reasonable cost of providing the services.
