

## **RESOLUTION NO. 2007-185**

Adopted by the Sacramento City Council

April 3, 2007

### **AGREEMENT: AUTHORIZING THE CITY OF SACRAMENTO TO CONTRACT WITH THE FRANCHISE TAX BOARD FOR PROVISION OF BUSINESS OPERATIONS TAX DATA**

#### **BACKGROUND**

- A. The law requiring cities to report business license data to the Franchise Tax Board (FTB) (California Revenue and Taxation Code Section 19556) was repealed in 1999. Therefore, in an October 2006 memorandum to California Cities, the FTB requested any interested city to supply the FTB with information regarding business license data for the 2006 tax year on a voluntary basis in exchange for compensation.
- B. The City was selected by the FTB and notified on March 1, 2007, of the opportunity to enter into an agreement whereby the City provides the FTB with its business tax data for the 2006 tax year. Exhibit A of Agreement Number C0600179 sets forth the scope of work.
- C. Participating cities will be paid through the 2006-07 California State Budget Appropriation for the costs associated with supplying the business operations tax data to the State. Exhibit B of Agreement Number C0600179 sets forth budget detail and payment provisions.
- D. As the State Budget appropriation to fund the program expires on June 30, 2007, the FTB has requested receipt of the executed Agreement in April, 2007.

#### **BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. The City Manager, or his authorized designee, is hereby authorized to enter into Agreement Number C0600179 between the City of Sacramento and California Franchise Tax Board for the City to provide business operations tax data to the FTB for the 2006 tax year.
- Section 2. The term of this agreement is April 1, 2007 through June 30, 2007.
- Section 3. The information provided under this agreement shall be used solely for the purpose of administration of tax and other non-tax programs that the FTB administers as set forth and provided by the California Revenue and Taxation Code Section 19504.



**EXHIBIT A****SCOPE OF WORK**

This Agreement is entered into by and between the Franchise Tax Board, herein referred to as (FTB) and the City of Sacramento, herein after referred to as the City.

1. The City agrees to provide the Franchise Tax Board (FTB) with tax information, per Exhibit E, Record Format Specifications, which shall include but not limited to the following:
  - a. Business name
  - b. Business address
  - c. Identification number  
(Federal employer identification number if the business is a partnership or corporation)  
(Owners name and social security for all others)
  - d. Type of business activity
2. Information may be submitted on standard CD-Rom or through a secure electronic connection in ASCII format, tab or comma delimited, per Exhibit E.
3. The records will be sent to the FTB project coordinator, Erica Gonzales no later than May 1, 2007.
4. The information obtained under this agreement will be used solely for the purpose of administration of tax and other non-tax programs that FTB administers as set forth and provided by the California Revenue and Taxation Code Section 19504.
5. Optional: With an executed Local Government Sharing Agreement for tax year 2006, the FTB will match the City Business Tax data received against records in the FTB Taxpayer Information (TI) System and Business Entity Tax System (BETS). Pursuant to the Revenue and Taxation Code Section 19551.1 and as stated by the Local Government Sharing Program Agreement, FTB will provide the City the following records for taxpayers within the City's jurisdiction who do not have a business license record per the data received from the City:
  - a. Taxpayer name
  - b. Taxpayer address
  - c. Taxpayer social security number or identification number
  - d. Principal business activity code

The information provided by FTB to the City will be used exclusively to administer the city business tax program established by the City. The City agrees that information obtained under this Agreement will not be reproduced, published, sold or released in original or in any other form for any purpose. See Local Government Sharing Agreement Terms and Conditions.

**EXHIBIT B**

**BUDGET DETAIL AND PAYMENT PROVISION**

1. **PAYMENT**: The FTB agrees to pay the City, not to exceed, \$16,000.00 for City Business Tax data. Upon receipt of the Agreement executed by the City, a usable file in the specified format, and a detailed invoice, the FTB agrees to remit payment for the cost incurred to the City in providing the data, based on the terms of this agreement.
2. **INVOICING**: The City shall render an invoice in triplicate to the FTB project coordinator or to:

3. **BUDGET CONTINGENCY CLAUSE**: It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under this Agreement does not appropriate sufficient funds for the program, this Agreement shall be of no further force and effect. In this event, the State shall have no liability to pay any funds whatsoever to Contractor or to furnish any other considerations under this Agreement and Contractor shall not be obligated to perform any provisions of this Agreement.

If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this program, the State shall have the option to either: cancel this Agreement with no liability occurring to the State, or offer an Agreement Amendment to Contractor to reflect the reduced amount.

4. **PROMPT PAYMENT CLAUSE**: Payment will be made in accordance with and within the time specified in Government Code, Chapter 4.5 (commencing with Section 927).

**EXHIBIT D****SPECIAL TERMS AND CONDITIONS**

1. **STATEMENT OF CONFIDENTIALITY:** The Franchise Tax Board has tax return information and other data in its custody, which is confidential data. Unauthorized inspection or disclosure of state tax return information or other confidential data is a misdemeanor (Revenue and Taxation Code Section 19542 and 19542.1.). Unauthorized inspection or disclosure of confidential data that includes Federal returns and other data is a felony (Sections 7213(a)(1) and 7213A(a)(1)(B) Internal Revenue code).
2. **USE OF INFORMATION:** The FTB agrees that the information furnished or secured pursuant to this Agreement shall be used solely for the purposes described by this Agreement. The information obtained shall be used for tax administrative and non-tax programs that FTB administers and may be shared with other state taxing agencies as authorized by law, including the Department of Child Support Services. The FTB and the City further agree that information obtained under this Agreement will not be reproduced, published, sold or released in original or in any other form for any purpose other than identified in this Agreement or as authorized by law.
3. **EMPLOYEE ACCESS TO INFORMATION:** The FTB and the City agree that the information obtained will be kept in the strictest confidence and shall make information available to its own employees only on a "need to know" basis. The "need to know" standard is met by authorized employees who need information to perform their official duties in connection with the uses of the information authorized by this Agreement. The FTB and the City recognize their responsibilities to protect the confidentiality of this information as provided by law and ensures such information is disclosed only to those individuals and of such purpose, as authorized by the Revenue and Taxation Code.
4. **DESTRUCTION OF RECORDS:** All records received by the FTB from the City and any database(s) created, copies made, or files attributed to the records received will be destroyed when they are no longer needed for the business purpose for which they were obtained. The records shall be destroyed in a manner to be deemed unusable or readable and to the extent that an individual record can no longer be reasonably ascertained.
5. **CANCELLATION:** The FTB may terminate this Agreement, in writing to the City for any reason, upon thirty days (30) prior written notice. This Agreement may be terminated by either party in the event of any breach of the terms of this Agreement.
6. **POTENTIAL SUBCONTRACTORS:** Nothing contained in this Agreement or otherwise shall create any contractual relation between the State and any subcontractors, and no subcontract shall relieve the City of its responsibilities and obligations hereunder. The City agrees to be as fully responsible to the State for the acts and omissions of the City's subcontractors and of persons either directly or indirectly employed by any of them as it is for the acts and omissions of persons directly employed by the City. The City's obligation to pay its subcontractors is an independent obligation from the State's obligation to make payments to the City. As a result, the State shall have no obligation to pay or to see the payment of any monies to any subcontractor.
