Recommendation: Adopt a **Resolution:** 1) approving Plans and Specifications for the Colonial Heights Street Improvements Project – 52nd Street between 14th Avenue and 15th Avenue (PN: RR22); and 2) awarding the contract for the Colonial Heights Improvements Project to Central Valley Engineering and Asphalt, Inc. in an amount not to exceed \$171,533.

Description/Analysis:

Issue: This project will reconstruct 52nd Street between 14th Avenue and 15th Avenue. The street improvements include reconstructing deteriorated pavement, constructing new curb, gutter and sidewalks, curb ramps, and installing street lighting.

Bids have been received and Central Valley Engineering and Asphalt, Inc. is the lowest responsive and responsible bidder. City Council approval is necessary to move forward with awarding a construction contract.

Policy Considerations: This action requested herein is consistent with the Sacramento City Code, Title 3 and with the City of Sacramento Strategic Plan goals of improving and expanding public safety.


Environmental Considerations: In accordance with the State Guidelines for Implementation of the California Environmental Quality Act (CEQA), the Planning Services Division, Environmental Section, has reviewed the proposed project.

This review has resulted in the determination that the proposed project will not have a significant adverse impact on the environment and a Categorical Exemption was prepared.

Rationale for Recommendation: Central Valley Engineering and Asphalt, Inc. is the lowest responsive and responsible bidder.

Financial Considerations: As of April 23, 2007, the Colonial Heights Street Improvement Project-52nd Street between 14th Avenue and 15th Avenue (PN: RR22) has an unobligated balance of \$300,137, which is sufficient to execute the contract with Central Valley Engineering and Asphalt, Inc. in the amount of \$171,533 and perform construction management of project.

Emerging Small Business Development (ESBD): This project has federal Community Development Block Grant (CDBG) funding from the Sacramento Housing Redevelopment Agency (SHRA) and requires that contractors demonstrate Good Faith Effort (GFE) toward engaging Minority/Women-Owned Business Enterprise (M/WBE) participation on the project.


