

## RESOLUTION NO. 2007-864

Adopted by the Sacramento City Council

December 4, 2007

### AWARD CONTRACTS FOR THE PURCHASE OF MEDIUM DUTY TRUCKS

#### BACKGROUND

- A. In support of various departments, the Department of General Services, Fleet Management Division, has a need to purchase medium duty trucks for the City's fleet.
- B. In September 2007, Procurement Services, in accordance with City Code Section 3.56, issued Invitation for Bid No. B081181011 for the purchase of medium duty trucks from various manufacturers. The bid was grouped into nine different categories by Gross Vehicle Weight Rating (GVWR) as shown in the table below. The City reserved the right to make multiple awards. This resolution recommends awarding a contract to the lowest bidder in each of the nine groups listed.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. Bonander Truck is awarded a one-year contract with two one-year renewal options for the purchase of medium duty trucks (Groups III and IX) in an amount not to exceed \$1,063,295.
- Section 2. Downtown Ford Sales is awarded a one-year contract with two one-year renewal options for the purchase of medium duty trucks (Groups I, II, IV, VII, VIII) in an amount not to exceed \$1,379,746.
- Section 3. Riverview International Trucks is awarded a one-year contract with two one-year renewal options for the purchase of medium duty trucks (Groups V and VI) in an amount not to exceed \$1,016,200.
- Section 4. The City Manager or the City Manager's designee is authorized to execute the contracts and annual renewal options specified above provided that sufficient funds are available in the budget adopted for the applicable fiscal year(s).


