

RESOLUTION NO. 2007-930

Adopted by the Sacramento City Council

December 18, 2007

AUTHORIZING A CONTRACT AMENDMENT WITH UC DAVIS, DEPARTMENT OF PSYCHIATRY FOR HEALTHCARE PROVIDER FOR THE DUI BRIEF INTERVENTION PROGRAM

BACKGROUND

- A. In 2005, the Sacramento Police Department, in collaboration with San Juan Mercy Hospital, sponsored a California Office of Traffic Safety (OTS) proposal to provide alcohol treatment assessment and intervention for repeat DUI drivers. The goal of this program proposal is to provide treatment intervention by Certified Alcohol Counselors during a potential “teachable moment” for repeat DUI offenders prior to their release from the County Jail.
- B. In April 2006, the County of Sacramento Board of Supervisors unanimously approved a resolution, supported by the Criminal Justice Cabinet, authorizing the implementation of the pilot DUI Brief Intervention Program at the County Jail.
- C. In June 2006, the Office of Traffic Safety awarded the City of Sacramento grant funding to implement a pilot DUI Brief Intervention Program.
- D. In August 2006, through City Council Resolution Number 2006-652, the City Council authorized the implementation of the grant-funded DUI Brief Intervention Program. By that resolution, the program was set to expire on December 31, 2007.
- E. In June 2007, City agreement Number 2007-0645 was signed between the Sacramento Police Department and County Sheriff’s Department to implement the various components of the DUI Brief Intervention Program at the Sacramento County Jail.
- F. The Sacramento Police Department currently contracts with UC Davis, Department of Psychiatry, for an OTS grant-funded healthcare provider to conduct DUI Interventions at the Sacramento County Jail (City Agreement Number 2007-0464). The contract expires on December 31, 2007.
- G. The program participants wish to continue the program, and an extended agreement with UC Davis is necessary for the program’s continued implementation. There is sufficient money remaining from the OTS grant funds to pay for an amended agreement with UC Davis.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

1. The City Manager of the City of Sacramento, or his designated representative, is hereby authorized on behalf of the City of Sacramento, to execute the First Amendment to Agreement to Provide Professional Medical Services with the University of California , with a not to exceed amount of \$228,483, to extend healthcare counseling services through July 31, 2009, for the DUI Brief Intervention Program in the City and County of Sacramento.
2. The term of the DUI Brief Intervention Program is extended until July 31, 2009, and will then expire unless additional program funding is obtained from State or local government, or private business or non-profit sources; or the California the Office of Traffic Safety provides renewal or carryover of program funding.


