Summary:

Attachment 1 is a tabulation of pricing submitted from sealed bids received by the City Clerk for furnishing trucking services in support of minor street repairs and delivery of plant mix materials for the Department of Transportation and for sludge disposal for the Department of Utilities. Staff recommends adopting the attached Resolution awarding contracts to: Chavez Trucking, Tim A. Manley Trucking, Inc., and D & N Associates, Inc. in a total accumulated amount not to exceed \$500,000 per contract year for these potential five-year contracts. Each of the contractors listed above are City certified Small Business.

Background Information:

- The Department of Transportation, Streets Services Division has a need for trucking services in support of minor street repairs and delivery of plant mix materials to various sites.
- The Department of Utilities, Plant Services Division has a need for trucking services to remove and dispose of water treatment sludge.
- In previous years, the two departments issued separate contracts and bids. This year the two separate bid processes were consolidated into one to reduce administrative costs and time associated with the bid solicitation and contract administration process.
- On June 15, 2005 Council suspended competitive bidding to allow for a Sheltered Market approach in the solicitation of a formal bid for trucking services. Invitations for Bid (IFBs) were sent to 17 City certified Emerging/Small Business Enterprise (ESBE) firms. Four responses were received and three were determined to be responsive.
- The Departments of Transportation and Utilities intend to use these three firms on a rotational basis based on their ability to provide the City waste hauling at the time and for the anticipated duration the City may require. The term of the contracts are for twelve months from the date of award with the option to extend the contracts on a year-to-year basis if mutually agreeable to both parties; however, in no case will the contracts extend beyond a total of five years.
- It is recommended that contracts be awarded to Chavez Trucking, Tim A. Manley Trucking, Inc., and D & N Associates, Inc. in a total accumulated amount not to exceed \$500,000 per contract year for these potential five-year contracts.

Financial Considerations:

Sufficient funds are available in the FY05/06 Street Maintenance operating budget (101-340-3492) and in the FY05/06 Water Production Operations budget (413-330-3321) for trucking services.

Environmental Considerations:

None

Policy Considerations:

These recommendations are consistent with Chapter 3.56.230(c) of the Sacramento City Code, which authorizes suspension of formal competitive bidding upon a two-thirds vote of the City Council. The Equal Benefits Ordinance (EBO) and the Living Wage Ordinance (LWO) are applicable to these contracts and Declarations of Compliance

were signed by each bidder. The recommendations in this report are consistent with the City's Strategic Plan to improve and diversify the transportation system.

Emerging Small Business Development (ESBD):

A Sheltered Market approach was used for the solicitation of bids for trucking services. The intent of the Sheltered Market concept is to increase the utilization of small businesses in City contracting. Under this approach, solicitation and acceptance of bids was restricted to City certified Emerging/Small Business Enterprises (ESBEs).

**APPROVING BID SPECIFICATIONS AND AWARDING TRUCKING SERVICES CONTRACTS
IN AN ANNUAL AMOUNT NOT TO EXCEED \$500,000.00 PER CONTRACT YEAR**

BACKGROUND

- A. The Department of Transportation, Streets Services Division has need for trucking services in support of minor street repairs and delivery of plant mix materials to various sites. The Department of Utilities, Plant Services Division has need for trucking services to remove and dispose of water treatment sludge.
- B. On June 15, 2005, Council suspended competitive bidding to allow for a Sheltered Market approach in the solicitation of a formal bid for trucking services. Invitations for Bid (IFBs) were sent to 17 City certified Emerging/Small Business Enterprise (ESBE) firms. Four responses were received and three were determined to be responsive.
- C. Firms will be used on a rotational basis based on their ability to provide the City waste hauling at the time and for the anticipated duration the City may require. The term of the contracts are for twelve months from the date of award with the option to extend the contracts on a year-to-year basis if mutually agreeable to both parties; however, in no case will the contracts extend beyond five years.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL
RESOLVES AS FOLLOWS:**

- Section 1. Specifications of Bid No. B051181029 for Trucking Services are hereby adopted and contracts awarded to the lowest responsible bidders.
- Section 2. The Procurement Services Manager is hereby authorized to issue the necessary purchase orders for this purchase in the amount of \$166,666.00 to Chavez Trucking, P.O. Box 365, Dixon, CA, 95620, in the amount of \$166,666.00 to Tim A. Manley Trucking, Inc., Box 292547, Sacramento, CA, 95829, and in the amount of \$166,666.00 to D & N Associates, Inc., P.O. Box 277465, Sacramento, CA, 95827 in a total accumulated amount not to exceed \$500,000 per contract year for these potential five-year contracts.
