**Subject:** PURCHASE OF TWENTY TRASH TRAILERS

**Recommendation:**

Adopt a Resolution: 1) adopt specifications of Bid No. B051181038 and accept the lowest responsible bid received in response to Procurement's solicitation for twenty trash trailers and 2) it is recommended that an award be made to Edward R. Bacon Co., in an annual amount not to exceed \$110,983.00.

**Summary:**

One responsive sealed bid was received by the City Clerk for furnishing twenty trash trailers in accordance with the specifications used in the bidding process. Staff recommends that Bid No. B051181038 for twenty trash trailers be awarded to Edward R. Bacon Co., in an annual amount not to exceed \$110,983.00, for this potential three year agreement. The recommended supplier meets all specifications.

**Committee/Commission Action:** None.

**Background Information:**

The Fleet Management Division of the General Services Department has a requirement for twenty trash trailers for use by the Parks and Recreation Department. These trailers are used to collect refuse and recyclable material from multiple locations for disposal at a central location.



After evaluating the prices paid on previous contracts for similar trailers and the cost of steel, staff has determined that the only bid offered to the City is fair and reasonable and therefore, recommends that the City Council accept the results of Bid No. B051181038 and authorize the Procurement Services Manager to issue the necessary purchase order to Edward R. Bacon Co., 5210 Florin-Perkins Rd., Sacramento, CA, in an amount not to exceed \$110,983.00, per year of this potential three year agreement.

**Financial Considerations:**

Sufficient funds are available in the Fleet Management operating budget for this purchase.

**Environmental Considerations:** None


**Policy Considerations:**
