Summary:

Gregory B. Bragg & Associates competitively bid this contract last in 2001. Agreement 2001-218 was for a term of three years with an option to extend for up to two additional years. The first amendment extended services for one year at an amount not to exceed \$280,000. The second amendment to this agreement is for the term of October 1, 2005 to September 30, 2006 at an amount not to exceed \$280,000.

Background Information:

Gregory B. Bragg & Associates has provided third party claims administration services to the City of Sacramento since 1990. Bragg staff handle all of the City's general and auto liability claims administration which equaled 548 incidents in FY 2005.

Financial Considerations:

Risk funds are available to pay for contract claims administration services.

Policy Considerations:

This contract amendment includes revisions that improve the liability claims administration process.

Emerging Small Business Development (ESBD):

BACKGROUND

- A. Gregory B. Bragg & Associates competitively bid this contract last in 2001 and has provided satisfactory brokerage services to the City of Sacramento since 1990. Agreement 2001-218 was for a term of three years with an option to extend for up to two additional years.
- B. The first amendment to this contract extended services from October 1, 2004 to September 30, 2005 at an amount not to exceed \$280,000.
