Summary:

Sacramento Area Council of Governments (SACOG) has issued a call for projects to receive federal and state funding from the recently enacted federal transportation act – Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU), and funding from the State Transportation Improvement Program (STIP).

Committee/Commission Action: None.

Background Information:

In September, SACOG announced that it would program two years of funding from the federal transportation act – SAFETEA-LU, and the funds available from the 2006 STIP. For the region, this amounts to \$100 to \$150 million. The funds available will most likely be on the lower end of this range.

This funding cycle will include funding for the four SACOG regional programs – Community Design, Bicycle and Pedestrian, Transportation Demand Management and

Air Quality. SACOG is reserving \$19 to \$31 million for these regional programs. The balance of the funds will be programmed to Regional Scale projects, Road Rehabilitation projects and a very small amount will go to Local projects to help provide regional equity. While \$100 to \$150 million may seem like a large amount of funding, agency staffs in the region have identified over \$350 million in funding needs just for Regional Scale projects in progress. SACOG staff has implied that the majority of the funds will go to Regional Scale projects under development.

Applications are due to SACOG on November 1, 2005 for all program areas except Community Design, which are due on January 12, 2006. Staff will return to Council in November with recommendations for the Community Design program.

Staff is recommending that Council adopt the projects listed below for submittal to SACOG as Tier 1 projects:

Cosumnes River Boulevard and I-80 Bike Bridge are recommended because the projects are under development and need funding for the next phases of work. Local Road Rehabilitation is an on-going program that has insufficient local funds to meet the needs. The Sacramento Intermodal Westside Access project will provide access to the existing depot and future intermodal. Based on the initial planning/feasibility studies, staff recommends requesting funds to begin project development for the Westside Access Project.

Strategically, staff believes that the City should also submit a few regional type projects that are eligible for Congestion Mitigation and Air Quality (CMAQ) funds, a type of federal funds. Projects funded with CMAQ funds must be able to demonstrate an air quality benefit. Normally SACOG staff handles matching the projects to the eligible funding sources. However, based on a preliminary project list developed by SACOG of potential submittals from agencies, it appears that there is less demand for CMAQ funds. If this is true, by submitting CMAQ eligible projects it might allow the City to receive additional funds. These projects can also serve as a "Plan B" because staff knows that the funding type for the Cosumnes project is extremely oversubscribed.

These projects are recommended because they have the ability to reduce congestion, improve air quality, are well defined, and located on major arterials that qualify for the funding.

Staff is recommending that Council adopt the projects listed below for submittal to SACOG as Tier 2 projects:

** These numbers are still being refined and may change.

With the adoption of the 2025 Metropolitan Transportation Plan, a new process for selecting the projects to receive federal funds is being used by SACOG. Local agencies submit their projects to SACOG. SACOG staff will prepare a recommendation based on the needs of the region and is not bound by “fair share” allocations. The schedule is as follows:

- November 1, 2005 Local agencies submit projects
- November 7 – 30, 2005 SACOG works with agencies and others to prioritize projects
- December 15, 2005 SACOG public hearing
- January 19, 2006 SACOG Board approval
- March 2006 New State Implementation Plan for air quality and Metropolitan Transportation Plan approved

SACOG is timing this programming cycle to coincide with the lifting of the air quality conformity lapse. According to SACOG this is scheduled for March of 2006.

Financial Considerations:

Federal and state funding will allow the city to deliver priority projects and programs sooner. Local match funding is available for the projects being recommended. Specific match funding will be determined once SACOG approves the City’s application and the specific SAFETEA-LU and STIP funds are designated by SACOG.

Environmental Considerations:



SELECTION OF PROJECTS TO SUBMIT TO SACOG FOR FUNDING

BACKGROUND

- A.
