Recommendation: Adopt a Resolution: 1) adopt specifications of Bid No. B061181020 and accept the lowest responsible bid received in response to Procurement's solicitation for a special weapons and tactical (S.W.A.T.) mobile vehicle and 2) it is recommended that an award be made to Braun Northwest, Inc., in a total amount not to exceed \$157,682.

Summary: Attached is a tabulation of sealed bids received by the City Clerk for furnishing a special weapons and tactical (S.W.A.T.) mobile vehicle in accordance with the specifications used in the bidding process. Staff recommends award of Bid No. B061181020 for a special weapons and tactical (S.W.A.T.) mobile vehicle be made to Braun Northwest, Inc., in a total amount not to exceed \$157,682. The recommended supplier meets all bid specifications

Committee/Commission Action: None.

Background Information: The Fleet Management Division of the General Services Department has a requirement for a special weapons and tactical (S.W.A.T.) mobile vehicle for use by the Police Department's Special Weapons and Tactics (SWAT) unit. The purchase of this vehicle is a replacement for the current vehicle used by the SWAT unit. This vehicle is specifically designed for SWAT operations including team transportation with enhancements for officer safety while in-route, rapid team deployment, tactical briefings, and secured storage for the specialized equipment

utilized by the SWAT team members. The current vehicle was purchased in 1987 and has exceeded its useful life expectancy. It is no longer feasible to maintain due to its age, increased cost and downtime.

Therefore, staff recommends that the City Council accept the results of Bid No. B061181020 and authorize the Procurement Services Manager to issue the necessary purchase order to Braun Northwest, Inc., 150 North Star Drive, Chehalis, WA, in a total amount not to exceed \$157,682.


Financial Considerations: Sufficient funds are available in the Fleet Management's Vehicle Replacement Fund (420-310-3259) to cover the cost of this purchase.

Emerging Small Business Development (ESBD): Invitation for Bids were sent to 10 vendors, three (3) of which are Emerging or Small Business Enterprises (ESBE). The recommended vendor, Braun Northwest, Inc., is not certified as an ESBE firm.


