Staff recommends that the City Council adopt the attached resolution that authorizes the City Manager to accept federal funding for expenses related to the deployment of members of the California Task Force-7, Urban Search and Rescue Team for Hurricane Katrina.

Summary:

The Federal Emergency Management Agency (FEMA) provides funding to federal Urban Search and Rescue Teams when deployed to disasters and national security events. California Task Force Seven (CA TF-7) Urban Search and Rescue (US&R) assets were deployed as part of the Type III Urban Search and Rescue Task Force, Swift Water Response Team, and members of Incident Support Teams (IST) for the response to Hurricane Katrina. The award amendments provide funding to cover the costs associated with the deployment of the teams. The amendments must be signed and returned to FEMA so that the funds will be obligated for reimbursement to the City of Sacramento.

Committee/Commission Action: None.

Background Information:

The City of Sacramento Fire Department is the sponsoring agency for CA TF-7 US&R team. At times, individual members from CA TF-7 US&R team are activated to provide overhead support to natural disasters and national security special events. The first of

several deployments began on August 27, 2005 when an IST member from CA TF-7 was activated by FEMA for response to Hurricane Katrina; subsequently the Swift Water Rescue Team was activated, followed by a Type III Team and numerous individuals to support the IST. The last members returned home from Katrina in mid-October. Costs incurred by CA TF-7 during the activations are reimbursed by FEMA. For each activation an award amendment is issued by FEMA to obligate the funds to provide reimbursement to the sponsoring agency. FEMA has issued three amendments for deployments of CA TF-7 to Hurricane Katrina. We are requesting authorization of the City Manager to sign the amendment to the Assistance Award agreement.

Financial Considerations:

As the sponsoring agency, the City of Sacramento incurs costs related to the activation of CA TF-7 US&R team. FEMA reimburses expenses directly related to the activation of the team. This agreement allows FEMA to obligate the funds for payment to the City of Sacramento Fire Department.


Environmental Considerations: None.


Policy Considerations:



ACCEPTANCE OF EMERGENCY FEDERAL FUNDING FOR CALIFORNIA TASK FORCE SEVEN URBAN SEARCH AND RESCUE TEAM

BACKGROUND

- A. The Federal Emergency Management Agency (FEMA) provides funding to federal Urban Search and Rescue Teams when deployed to disasters and National Security events. CA TF-7 deploys members to events each year as needed. The amendments must be signed and returned to FEMA so that the funds will be obligated for reimbursement to the City of Sacramento.
- B. The first of several deployments began on August 27, 2005 when an IST member from CA TF-7 was activated by FEMA for response to Hurricane Katrina; subsequently the Swift Water Rescue Team was activated, followed by a Type III Team and numerous individuals to support the IST. The last members returned home from Katrina in mid-October. FEMA has issued three amendments for deployments of CA TF-7 members to Hurricane Katrina. We are requesting authorization of the City Manager to sign the amendments to the Assistance Award agreement.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. That the City Manager, or his designee, is authorized to sign the Assistance Award Amendment (M020, M022, and M024) for funding the deployment of selected members of California Task Force Seven Urban Search and Rescue Team to Hurricane Katrina.
- Section 2. The award amount of M020 amendment is \$1,992,000, the award amount of M022 amendment is \$422,800, and the award amount of M024 amendment is \$56,000 for the anticipated reimbursement of costs associated with deployment to the hurricane.
- Section 3. The operating grant revenue and expenditure appropriations are increased as follows:
