Subject: Innovative Laundry Systems Sewer Credits

Adopt a Resolution awarding a total of nineteen and a half (19.5) Sacramento Regional County Sanitation District (SRCSD) connection fee credits to the described business known as Innovative Laundry Systems.

Summary:

The Economic Development Department recommends adoption of the attached Resolution awarding SRCSD sewer credits to the business known as Innovative Laundry Services, publicly known as "P L Coin Laundry," located at 6100 Mack Road, Suite 800 (APN #: 117-0012-017) near the intersection of Mack Road and State Highway 99. This candidate for sewer credits meets Council-approved criteria for the granting of sewer credits because it is a locally-owned business and because it will be reusing an existing vacant structure and contributing to urban infill development.

Committee/Commission Action: None

Background Information:

On March 20, 2001, City Council authorized the City Manager to sign a Memorandum of Understanding (MOU) to initiate City participation in the Sacramento Regional County Sanitation District connection fee credits program for award by the City. The MOU

allocated a total of 7,971 Regional Sanitation sewer credits to the City of Sacramento for award by the City to qualifying development projects.

Approval of the MOU followed prior action by the City Council to approve Resolution No. 2000-539 on September 12, 2000, which established the guidelines and criteria by which credits would be granted. On July 18, 2002, Resolution 2002-498 amended those guidelines. On January 27, 2004, Resolution 2004-062 further amended the guidelines, in part, to read as follows.

- A. If the project is located in a City Council designated infill area the prospective project must create one additional Full-time job, new employment aside from the employment of the project applicant (s). (See attached infill map)
- B. In the event the prospective project is located outside the designated infill area, a prospective project will be considered if it meets at least one of the following three conditions:
 1. It is a high job creation project. The project must create a minimum of 35 new full-time jobs.
 2. It is a locally owned and operated business and creates at minimum 3 new full-time jobs.
 3. It is a "catalyst project." In order to be awarded credits, the City Council must find that the proposed project is a "catalyst project," i.e. a project that furthers economic development activity consistent with the adopted Economic Development Strategy.
- C. Any project that falls into the above criteria and uses less than 15 credits can be approved at staff level. All projects using more than 15 credits require approval by the City Council.

Prior approvals for SCRSD connection fee credits include Mikuni's Midtown at 16th and J Streets, Pyramid Alehouse at 1029 K Street, and the Marriott Residence Inn, currently under construction at 15th and L Streets in Downtown.

On July 13, 2004, the City received an application from Innovative Laundry Systems, known publicly as "P L Coin Laundry," for an award of 19.5 sewer credits. PL Coin Laundry will reuse a vacant facility at 6100 Mack Road, Suite 800. It will have 32 commercial washers serving an underserved area in need of a laundry facility. This facility will be a locally owned and operated business and will create twelve full-time jobs. Award of the requested 19.5 sewer credits will reduce total Regional Sanitation fees to be paid for this project from \$48,750 (at \$2,500 apiece) to approximately \$17,998.50 (at \$923 apiece).

Based upon a review of the application (Attachment 1), staff concludes that the applicant meets Council-approved objectives for the granting of sewer credits by the planned reuse of an existing vacant structure and urban infill development.

The award of 19.5 sewer credits to Innovative Laundry Systems will leave a total of 5543.216 sewer credits for future award by the City to support economic development projects.

The summary of the City Economic Development Department sewer credit award activity to date (Attachment 2) and the SRCSD Quotation (Attachment 3) are attached.

Financial Considerations: There are no funding requirements related to this project.


Environmental Considerations:



**A RESOLUTION AWARDING ECONOMIC DEVELOPMENT TREATMENT CAPACITY BANK
CONNECTION FEE CREDITS BY SACRAMENTO REGIONAL COUNTY SANITATION
DISTRICT (SRCSD) FOR INNOVATIVE LAUNDRY SYSTEMS**

BACKGROUND

- A. On March 20, 2001, City Council authorized the City Manager to sign a Memorandum Of Understanding (MOU) to initiate City participation in the Sacramento Regional County Sanitation District Economic Development Treatment Capacity Bank (CC2001-177);

- B. Eighty-five percent (85%), or 6,775 of the total 7,971 ESD's (Equivalent Single-family Dwelling units) made available to the City of Sacramento under the MOU are allocated for economic development projects, the award of which must be approved by City Council resolution;

- C. Innovative Laundry Systems, publicly known as "P L Coin Laundry," located at 6100 Mack Road Suite 800 in Sacramento meets City economic development objectives by being in the City Council designated infill area.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL
RESOLVES AS FOLLOWS:**

- 1. City Council hereby awards a maximum of 19.5 ESD credits from the Sacramento Regional County Sanitation District Economic Development Treatment Capacity Bank to Innovative Laundry Systems located at 6100 Mack Road, Suite 800 in Sacramento (APN: 117-0012-017).

- 2. Any and all credits awarded herein to each individual recipient shall expire if said individual recipient has not paid its requisite sewer impact fee to SRCSD within one year from the date of approval of this resolution.

- 3. Any and all credits awarded herein to each individual recipient will expire if said individual recipient has not been issued a building permit for its respective above referenced development project within one year after the City Council has awarded use of the aforementioned sewer credits.

- 4. Award herein of 19.5 sewer credits will leave a total of 5543.216 sewer credits for future award by the City to support economic development projects.
