Summary:

Advising the City Council of the appointment of two active SCERS members to the Retirement Hearing Commission.

Background Information:

On February 28, 2006, the City Council received a report advising of the City Clerk's intent to hold an election to fill two seats on the Retirement Hearing Commission. A nomination period was opened so that active SCERS members could be nominated. At the close of the nomination period on March 10, 2006, only one candidate for each seat was nominated.

As outlined in Resolution 89-712, when only one candidate is nominated for a seat, the candidate shall automatically be deemed elected by the City Clerk. The Clerk's Notice of Appointment is attached.

In addition, within ten days of the Council receiving this report (or Friday, April 14, 2006), active SCERS members may file an appeal with the City Clerk challenging the election procedures, results, or any other aspect of the election. If an appeal is filed, the matter will be brought before the City Council for review.


